### UMphathi

Ulawulo lwelifa lwenzeka ngaphantsi kweliso loMphathi onamandla omthetho kuxhomekeka idilesi apho umfi ebehlala khona kwiinyanga ezili-12 ezidlulileyo. Kukho iiOfisi zoMphathi: eBloemfontein, eKapa, eMakhanda, eKimberley, eMmabatho/eMafikeng, eNelspruit, ePietermaritzburg, ePitoli, eMthatha, eBisho, eThohoyandou, Johannesburg, ePolokwane, Durban, kunye naseGqeberha.

### Umabimafa

- Umabimafa ngumntu omiselwe nguMphathi ukuze alawule ilifa lomfi.
- Umfi ukhetha umabimafa ngokokuthanda kwakhe yaye uMphathi umisela loo mabimafa kwiimfuno ezithile.
- Ukuba umfi akakhange amisele umabimafa, abantu abaza kuzuza banokukhetha umabimafa oza kumiselwa nguMphathi.
- Ukuba ilifa lilawulwa ngaphantsi kwecandelo 18(3) loMthetho Wolawulo Welifa (othetha inani elikhulu lelifa elingaphantsi kwe-R250 000) uMphathi umisela umabimafa ekubhekiselwa kuye ngokuthi ngummeli woMphathi (Kwakhona kubhekiselwa kulo njengecandelo 18(3) lweapoyintimenti).
- Umabimafa nguye onoxanduva lolawulo lwelifa.

- Umabimafa okhethiweyo unokukhetha iarhente eza kummelakodwa umabimafa nguye ngokusemthethweni onoxanduva lwelifa.
- Ukuba igosa limiselwe, Amandla omthetho i-power of attorney kumele abekho.

### **Igqwetha lobhalisozitayitile**

- Igqwetha lobhalisozitayitile ligqwetha elisebenza ngokukhethekileyo ekulungiseleleni amafa kunye namaxwebhu ngokoMthetho okanye uqheliselo olwenziwayo olubhalisiweyo kubhaliso lwamafa.
- Igqwetha lobhalisozitayitile unxibelelane neofisi yoBhaliso lweeTayitile ukuze anyamekele ukudluliselwa kwelifa xa umfi ebengumnini wempahla ehambayo emele idluliselwe kwiindlalifa okanye ithengiswe yaye idluliselwe kwiqela lesithathu.

### **INkonzo yeRhafu yaseMzantsi Afrika**

Injongo yeNkonzo yeRhafu yaseMzantsi Afrika (SARS) kukuqokelela zonke iirhafu yaye kwimeko yokufa kukuqinisekisa ukuba zonke iirhafu ziyahlawulwa.

- Inombolo Yerhafu Yengeniso yomfi (kunye nezinye iinombolo zerhafu ezifanelekileyo) zimele zikhowudwe njengelifa lomfi kwi- SARS.
- Yonke irhafu yengeniso (zonke iirhafu umfi ebebhaliselwe zona umz. i-VAT, i-PAYE) kunye namatyala amele ahlawulwe yaye irhafu yelifa imele ithunyelwe ngokuvumelana nerhafu yelifa.

Xa isaziso sokufa sifunyenwe, simele sithunyelwe kwiSebe leMicimbi yezeKhaya neefomu ezifunekayo (DHA1663) kunye neDHA132 (isicelo sesatifikethi sokufa) emele igcwaliswe ukuxela ukufa yaye nokufumana isatifikethi

sokufa. lifomu zifumaneka kwiwebhusayithi yeSebe lezeKhaya LoMzantsi Afrika ([https:// www.dha.gov.za](https://www.dha.gov.za)).

ISatifikethi sokufa esishwankathelweyo asihlawulelwa xa sikhutshwa ngosuku olufanayo okubhaliswe ngalo ukufa, noko ke, isatifikethi esingashwankathelwanga sinokufumaneka ngokuzalisa ifomu ethi DHA132 kunye nentlawulo efunekayo.

### **Inyathelo 3: Ukumiselwa komabimafa**

Ukuba umfi ebenayo incwadi yelifa yaye ekhethe umabimafa ukuba amiselwe nguMphathi, umabimafa onjalo waziwa ngokuthi umenzi welifa womyolelo i-executor testamentary.

Ukuba incwadi yelifa akhange yenze isibonelelo somabimafa okanye umfi uye wafa ngaphandle kwencwadi yefa, uMphathi uza kumisela umabimafa ekubhekiselwe kuye njengomabimafa omiselweyo ngumthetho i-executor dative.

Umabimafa unokumisela iarhente ukuba umabimafa uziva engakufanelekeli ukwenza ilifa, lo gama nje Amandla omthetho i-power of attorney ekhona.
