**SUBJECT: IMPLEMENTATION OF TEMPORARY IMPORTATION
DECLARATION REQUIREMENT FOR MOTOR VEHICLES ENTERING
SOUTH AFRICA**

1. We wish to inform you of the upcoming enforcement of the requirement for all foreign-registered motor vehicles, including those from SACU countries, to complete a temporary importation declaration when entering South Africa.
2. This requirement is in line with Section 15 of the Customs and Excise Act, which mandates the declaration of all goods, including vehicles, upon entry. The SACU Agreement does not exempt member states from compliance with South African national legislation regarding import controls.
3. Previously, SACU-registered vehicles were temporarily exempted from this requirement due to operational challenges at border posts. With the introduction of improved systems, including the Travel Management System (TMS) and the Mobi App for pre-declaration, these challenges have been addressed. The TMS enables travellers to submit customs declarations electronically in advance, allowing for preliminary processing, verification, and approval prior to arrival at the borders. This process significantly enhances operational efficiency, minimizing congestion, and expedites border movements on traveller declarations at all borders.

4. For TMS registration, submission guidelines, and support, please visit <https://www.sars.gov.za/travellerdeclaration/>. There will also be officials on the ground across our borders to assist with this process.
5. Effective 1 June 2026, all SACU-registered vehicles entering South Africa must comply with the temporary importation declaration process.
6. We request your cooperation in communicating this requirement to all relevant stakeholders and ensuring readiness for implementation / enforcement by the effective date. Should you require further information or assistance, please contact:
