 The exemption certificate is issued based on the information submitted in this document. If the information turns out to be incorrect, or if contractual agreements other than the specimen copies submitted are used, the exemption certificate would be invalid. Your local SARS branch office must be advised of any change in trading name or postal address. Exemption certificates issued are valid for a maximum period of twelve months within a specific tax year. Application for certificates must therefore be applied for on an annual basis. Exemption certificates are valid from the day of application and cannot be backdated. An application for an IRP30 exemption certificate must be submitted to the SARS branch office where the applicant is registered for Income Tax purposes two months prior to the expiry date of the current certificate. The application form to register as a Labour Broker (IRP30A) is available on the SARS website www.sars.gov.za or at your local SARS branch office.
