1 SUMMARY

a) The SARS MobiApp allows individual taxpayers and tax practitioners to request their tax directives. Additionally, taxpayers and tax practitioners can request and generate previously issued tax directives. Tax Directives form part of the Income Tax that is governed by the Income Tax Act of 1962, thus play a vital role in the compliance of taxpayers. These digital enhancements are there to assist taxpayers/ tax practitioners on the ease of tax compliance in the comfort of their homes. This guide will describe how taxpayers /tax practitioners can use their smart devices to install the SARS MobiApp and use it to view their tax directives and where necessary download the PDF version of the related tax directive letters or forms.

2 INTRODUCTION

- a) The SARS Online Tax Directive supports the end-to-end tax directive application process. Applicants are able to access the front-end of this application via eFiling and complete the various processes of tax directives. One such support enhancement is the tax directive simulation. This front-end functionality allows eFilers who are employers, fund administrators or long-term insurers, to request and obtain simulated calculations on a tax directive before submitting the application for an actual tax directive.
- b) The SARS MobiApp is one of the SARS online front-end channels that a taxpayer/ tax practitioner can use to resolve their tax queries. The SARS MobiApp is a mobile application which can be installed on your mobile device and is compatible with numerous mobile devices. These devices include Android (version 5.0 or higher), iOS (version 10.0 or higher) operated devices or the Huawei app gallery.

3 SARS MOBIAPP

3.1 How to install the SARS MobiApp

- a) The following operating systems versions are required to enable installation of the SARS MobiApp to your smart phone/device:
 - i) Android Version 5.0 or Higher
 - ii) iOS Version 10 or Higher
 - iii) Huawei Version 10 or Higher
- b) For an Apple device:
 - i) Apple users should navigate to the App Store
 - ii) Search for "SARS MobiApp"
 - iii) Install the application.
- c) For an Android device:
 - i) Andriod users should navigate to the Google Play Store
 - ii) Search for "SARS MobiApp"
 - iii) Install the application.
- d) For a Huawei device:
 - i) Huawei users should navigate to the Huawei app gallery.
 - Huawei app gallery.Search for "SARS MobiApp"
 - iii) Install the application





3.2 How to register for the use of the SARS MobiApp

- a) The SARS MobiApp is interrelated to eFiling. This implies that you can use your eFiling username and password to access the SARS MobiApp.
- b) If you are not registered,
 - i) Tap on to the "**Registration**" tab.
 - ii) Complete the questions to finalise the registration process.
- c) Alternatively select "**Register**" displayed at the bottom of your screen device.
 - i) Complete the questions to finalise the registration process.

- a) You can access historical tax directives in one of the following.
 - i) On the "Welcome page" and
 - A) Tap on the "**Directives**" tab.
 - B) Complete your Username and Password.
 - C) Once completed, tap on "Login"

How to request Historical Tax Directive 3.4

- a) Login to your profile
 - Upon logging on successfully, navigate to "My Services" menu. i)
- b) Tap on "Request Historic Directives," displayed on the "My Services" menu.





- When "Request Historic Directives" tab is tapped: c)
 - You will be presented with the Request Historic Directives screen containing the following fields:
 - **Tax Reference number** This displays your tax reference number. **ID number** This displays your ID number. A)

 - D) Tax Year To – This displays the end year which the Directives request is made.

 - i) Where a letter is selected the letter will be displayed on your device
 - To download, tap on
 "Download" and follow the prompts.

- b) Once the tax directive list is displayed on your device, select the tax directive by tapping on the applicable directive's details.
 - i) Where a form was selected the form will be displayed on your device
 - ii) To download, tap on "**Download**" and follow the prompts.
