

**NOTES REGARDING AMENDMENTS TO THE SCHEDULES  
TO THE CUSTOMS AND EXCISE ACT, 1964**

**23 SEPTEMBER 2005**

These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.

7306.40	A provisional payment in relation to anti-dumping duty is imposed on stainless steel tubes and pipes, welded, of circular cross-section with an outside diameter of 12 mm or more but not exceeding 160 mm and with a wall thickness of 1 mm or more but not exceeding 6 mm, originating in or imported from China.
7306.40	A provisional payment in relation to anti-dumping duty is imposed on stainless steel tubes and pipes, welded, of circular cross-section with an outside diameter of 12 mm or more but not exceeding 160 mm and with a wall thickness of 1 mm or more but not exceeding 6 mm, originating in or imported from India.
7306.40	A provisional payment in relation to anti-dumping duty is imposed on stainless steel tubes and pipes, welded, of circular cross-section with an outside diameter of 12 mm or more but not exceeding 21,34 mm and with a wall thickness of 1 mm or more but not exceeding 6 mm or from 114 mm or more but not exceeding 160 mm and with a wall thickness of 1 mm or more but not exceeding 6 mm, originating in or imported from Malaysia.

**CUSTOMS AND EXCISE ACT, 1964.-  
IMPOSITION OF PROVISIONAL PAYMENT (PP/119)**
