

EXPLANATORY MEMORANDUM-TECHNICAL AMENDMENTS

TECHNICAL AMENDMENTS TO THE CUSTOMS AND EXCISE ACT, 1964

The draft amendments in Part 1 of Schedule No. 1 to the Customs and Excise Act, Act No. 91 of 1964 (the Act), are technical in nature and <u>will have no effect on the</u> <u>duty structure</u>. The amendments are mostly due to requests received from industry or other government agencies.

1. AMENDMENT OF PART 1 OF SCHEDULE NO. 1

1.1 Request from the Department of Forestry, Fisheries and Environment

In terms of the Biodiversity Act, No. 10 of 2004, derivatives of endangered species are protected and prohibited from being imported into or exported out of South Africa. A workshop was held between SARS and Department of Forestry, Fisheries and Environment (DFFE) to update the list of Prohibited and Restricted (P&R) goods and the information under the control of DFFE. It transpired that some derivatives such as elephant tusks and rhinoceros horn, which as a collective are defined as "ivory" of indigenous species listed as critically endangered in terms of section 56 to the said Act, are not included in the P&R list. These products are classified under tariff heading 0507.10.

This has been identified as a high risk for illegal movement of tusks and horns of endangered species to go undetected and without the necessary permits required in terms of the said Act. The DFFE, therefore, requested that these goods be provided for by the creation of 8-digit separate tariff subheading. This will address the proper reference and restrictions as it relates to specifically elephant tusks and rhinoceros horn under "Ivory".

1.2 Request from the South African Rooibos Council for the creation of a separate 8-digit tariff subheading under the correct tariff subheading

The 70th Session of the Harmonised System Committee (HSC) re-classified the plant *Aspalathus linearis*, otherwise known as Rooibos or Bush tea under tariff heading 1211.90. The product was initially determined and as such provided for under tariff heading 1212.99. The HSC will consider creating a 6-digit international tariff heading with the roll out of the 8th edition of the Harmonised System, however, that process will take approximately four years until the next edition is ready.

1.3 Request from XA Global Advisors on behalf of Tiger Brands for the creation of separate 8-digit tariff subheadings for tomato paste

XA Global Advisors on behalf of Tiger Brands requested that separate 8-digit tariff subheadings be created to provide for the different types of tomato paste. As a reason for the request, they stated that the granular categories for tomato pastes will assist them to gather import statistics. They further stated that having an elaborate structure should enable the International Trade Administration Commission to administer rebate item 304.07/2202.90/0106 more effectively while remedying the possible abuse of the rebate item.

1.5 Request from the Department of Trade, Industry and Competition (Thedtic) for the amendment of tariff subheadings provided for human vaccines

The dtic requested an amendment on the tariff subheadings provided for vaccines classified in tariff heading 3002.41. The Biologicals and Vaccines Institute of South Africa (Biovac) which is a public-private entity was established in 2003 to revive the vaccine development and manufacturing capabilities in South Africa. The Covid-19 pandemic has highlighted the need for countries to develop their manufacturing capacity of vaccines and South Africa has proven to have capacity capabilities to fill and finish of Covid-19 vaccines. Currently South Africa is dependent on imports of vaccines from Belgium, United States of America, Ireland and France. Biovac has been the sole supplier of supplier of the Expanded Programme on Immunisation (EPI) for the National and Provincial Health Department. Recent changes in the immunisation regime requires a new vaccine as part of the programme.

As a local formulator, Biovac imports bulk products and applies value add to provide for provide for retailing for distribution and use within the public sector. The entry of new suppliers of vaccines may negatively affect the uptake of locally manufactured vaccines. As such, there is a need to distinguish between bulk product and those which come put up in forms or packings for retail sale or in measured doses.

1.6 Request from the Southern African Institute of Steel Construction for the creation of separate 8-digit subheadings

The Southern African Institute of Steel Construction (SAISC) requested a creation of separate 8-digit tariff subheadings for the steel products that are used in the automotive industry in order to distinguish them from all other products classifiable under the residual tariff subheadings. They also requested for the creation of 8-digit tariff subheadings for other steel products to provide for specific range in thickness to distinguish them from those due for an increase in the rate of duty.
