EXTENSION OF DATE TO REQUEST A REDUCED OR ADDITIONAL ASSESSMENT IN TERMS OF SECTION 95(6) OF THE TAX ADMINISTRATION ACT, 2011 (ACT NO. 28 OF 2011)

In terms of section 95(6) of the Tax Administration Act, 2011, I, Edward Christian Kieswetter, Commissioner for the South African Revenue Service, hereby extend the date by which a taxpayer, eligible for automatic assessment under paragraph 3(3) of Notice No. 4918 published in Government Gazette No. 50741 dated 31 May 2024, may request a reduced or additional assessment, to 21 October 2024. The extension does not apply if the date of the automatic assessment is after 23 August 2024.
