## ISheduli

### 1. Okwejwayelekile

(1) Noma yiliphi itemu noma ibinza lamagama elikulesi saziso incazelo yalo inikeziwe “eMthethweni Wentela” njengalokhu kuchaziwe esigabeni soku-1 soMthetho Wokuphathwa Kwentela, wezi-2011, linaleyo ncazelo eliyinekeziwe, ngaphandle uma indikimba isho okunye kanti amatemu alandelayo analezi zincazelo ezilandelayo—

**“Unyaka wokuhlola wezi-2026” usho—**

- (a) lapho kukhulunywa ngenkampani, unyakamali wenkampani ophela ngesikhathi sekhalenda lonyaka wezi-2026; kanti
- (b) lapho kuyinoma yimuphi omunye umuntu, unyaka wokuhlola ophela esikhathini esiyizinyanga eziyi-12 eziphela mhla zingama-28 kuNhlolanja 2026;

**“ifomu lemininingwane ngentela yemalingeniso”** asho amafomu eminingwane okuhlolwa kwentela eyejwayelekile okumaqondana nonyaka wokuhlola wezi-2026 okuhlanganisa namafumuniningo entela yesambamalingeniso sebhizinisi uma umuntu eyibhizinisi elincane elibhalisile ngaphansi kweSheduli yeSithupha yoMthetho Wentela Yemalingeniso; kanti **“ithrasti”** isho ithrasti njengoba ichaziwe kusigaba soku-1 soMthetho Wentela Yemalingeniso.

(2) Ngalokhu kukhishwa isaziso ngokwesigaba sama-25 soMthetho Wokuphathwa Kwentela, sifundwa ndawonye nesigaba sama-66(1) soMthetho Wentela Yemalingeniso, ukuthi umuntu obalulwe ngokwendima yesi-2 kumele athumele ifomu lemininingwane yentela ngesikhathi esibekiwe kundima yesi-4.

### 2. Abantu okudingeka bathumele ifomu lokubuyisa imininingwane ngentela

  - (iv) obe nemalingeniso etheliswayo, isambamalingeniso senhizinisi esitheliswayo, ulahleko oluhloliwe noma ulahlekomali oluhloliwe;
- (b) Wonke amathrasti ayengumhlali ngesikhathi sonyaka wokuhlola wezi-2026;
- (c) Zonke izinkampani, amathrasti noma umuntu ngokomthetho, obengesona isakhamuzi ngonyaka wokuhlolwa wezi-2026, owenze lokhu—
  - (i) oqhubekile nokuhweba esebenzisa isakhiwo esingenakuguqulwa kuRiphabhulikhi;
  - (ii) othole imalingeniso emthonjeni okuRiphabhulikhi; noma
  - (iii) othole inzuzomali noma ulahlekomali ngokuchitha impahla okusebenza kuyo iSheduli yesiShiyagalombili yoMthetho Wentela Yemalingeniso;
- (d) Zonke izinkampani ezihlanganisiwe, ezisungulwe noma ezakhiwe kuRiphabhulikhi, kodwa ebezingezona isakhamuzi ngenxa yokusebenza kwanoma yisiphi isivumelwano okungenwe kuso noHulumeni wanoma yiliphi elinye izwe ukuze igweme ukutheliswa kabili ngesikhathi sonyaka wokuhlola wezi-2026;
- (e) Namuphi umuntu ngokwemvelo ngesikhathi sokuhlolwa sonyaka wezi-2026—

- (i) obengumhlali futhi oqhubekile nanoma yiluphi uhwebo (ngaphandle komsebenzi awenze ngoba eqashiwe kuphela); noma
- (ii) ubengesona isakhamuzi futhi waqhubekile nanoma yiluphi uhwebo (ngaphandle komsebenzi awenze ngoba eqashiwe kuphela) kuRiphabhulikhi;
- (f) Namuphi umuntu ngokwemvelo ngesikhathi sokuhlolwa sonyaka wezi-2026—
  - (i) ubengumhlali futhi enenzuzomali noma imalilahleko okwevile ku-R40 000;
  - (ii) wayengemhlali futhi othole inzuzomali noma ulahlekomali ngokuchitha impahla okusebenza kuyo iSheduli yesiShiyagalombili yoMthetho Wentela Yemalingeniso;
  - (iii) ebengumhlali futhi enezimali zangaphandle noma enempahla ngaphandle kweRiphabhulikhi, lapho intengonani ephelele yalezo zimali futhi izimpahla zevile ku-R250 000 noma kunini ngesikhathi sonyaka wokuhlolwa wezi-2026;
  - (iv) wayengumhlali futhi futhi imalingeniso noma inzuzomali ezimalini zangaphandle noma izimpahla ngaphandle kweRiphabhulikhi bezingenxa yoMthetho Wentela Yemalingeniso;
  - (v) ubengumhlali futhi enamalungelo okubamba iqhaza, okukhulunywe ngawo esigabeni sama-72A soMthetho Wentela Yemalingeniso, enkampanini elawulwayo yangaphandle ;
  - (vi) wayeyisakhamuzi futhi enesambamalingeniso sebhizinisi esitheliswa; noma
  - (vii) ngaphansi kokuhlinzekelwa indima yesi-3, ekupheleni konyaka wokuhlola wezi-2026—
    - (aa) wayengaphansi kweminyaka yobudala engama-65 omalingeniso yakhe engakacozulwa yevile ku-R95 750;
    - (bb) wayeneminyaka yobudala engama-65 noma ngaphezulu (kodwa ngaphansi kweminyaka yobudala engama-75) omalingeniso yakhe engacozuliwe yevile ku-R148 217; noma
    - (cc) wayeniminyaka engama-75 yobudala noma ngaphezulu omalingeniso lakhe elingacozuliwe yevile ku-R165 689;
- (g) ngaphansi kokuhlinzekelwa indima yesi-3, yonke impahla kamufi enemalingeniso elingacozuliwe ngonyaka wokuhlolwa wezi-2026;
- (h) Namuphi umuntu ongemhlali omalingeniso yakhe engakacozulwa ngesikhathi sonyaka wokuhlolwa wezi-2026 kufake phakathi inzalo evela emthonjeni okuRiphabhulikhi lapho okungasebenzi khona ukuhlinzekela kwesigaba 10(1)(h) soMthetho Wentela Yemalingeniso;
- (i) Wonke umuntu obhalelwe nguKhomishana emcela ukuba athumele ifomu lemininingwane ngentela, kungakhathaleki inani lemalingeniso noma uhlolo etholakele ngayo noma okuqongelelwe umuntu; kanye
- (j) Namuphi ommele umkhokhintela wanoma yimuphi umuntu okukhulunywe ngaye emaphuzwini
  - (a) kuya ku-(i) ngenhla.

### 3. Abantu okungadingeki bathumele ifomu lokubuyisa imininingwane ngentela

- (1) Umuntu ngokwemvelo noma umuntu onempahla yomufi akudingeki ukuba bathumele ifomu lokubuyisa imininingwane ngentela ngokwendima 2(f)(vii) noma (2)(g) lapho imalingeniso engakacozulwa yomuntu ngesikhathi sokuhlolwa sonyaka wezi-2026 inemali echazwe ephuzwini noma emaphuzwini alandelayo kuphela:
  - (a) Umholo (ngaphandle komholo okukhulunywe ngawo ephuzwini (e)) okhokhwe noma okufanele ukhokhwe umqashi oyedwa futhi ungevile ku-R500 000 nentela yabasebenzi isidonsiwe noma isibanjiwe ngokwamathebula okubanjelwa amiswe nguKhomishana;
  - (b) Inzalo (ngaphandle kwenzalo ephuma kutshalomali olungenayo intela) evela emthonjeni kuRiphabhulikhi engevile—
    - (i) ku-R23 800 uma kungumuntu ngokwemvelo ongapansi kweminyaka yobudala engama-65 ekupheleni konyaka wokuhlolwa;

- (ii) ku-R34 500 uma kungumuntu ngokwemvelo oneminyaka yobudala engama-65 noma ngaphezulu ekupheleni konyaka wokuhlolwa; noma
  - (iii) ku-R23 800 uma kungumuntu onefa eliyimpahla yomufi;
  - (c) Imihlomulonzuzo engatheliswa intela evamile futhi umunt ngokwemvelo wayengemhlali ngonyaka wokuhlola wezi-2026;
  - (d) Amanani atholakale noma aqongelelwe kutshalomali olungatheliswa intela; kanye
  - (e) Umhlomulo wesamba esisodwa esitholakale esikhwameni sempesheni, isikhwama sokuhlinzekela, isikhwama sokulondoloza sempesheni, isikhwama sokulondoloza sokuhlinzekela noma isikhwama se-anuwithi yomhlahaphansi, nentela isidonsiwe noma isibanjiwe ngokomyalelo okhishwe uKhomsishana.
- (2) Indinyana (1) ayisebenzi kumuntu ngokwemvelo—
- (a) okhokhelwe noma onikwe isibonelelo noma imali ekhokhwa phambi kwesikhathi njengoba ichaziwe esigabeni se-8(1)(a)(i) soMthetho Wentela Yemalingeniso ngaphandle kwenani alibuyiseliwe noma alikhokhelwe phambi kwesikhathi njengoba kuchaziwe esigabeni se-8(1)(a)(ii) noma isibonelelo noma imali ayikhokhelwe phambi kwesikhathi okukhulunye ngayo esigabeni se-8(1)(b)(iii) engadluli enanini elinqunywe ngokusebenzisa isilinganisonani esifakwayo ngekhilomitha ngalinye ngendlela eyenziwe lula esazisweni esinquma inani elikhokhwayo ngekhilomitha ngalinye ngaphansi kwesigaba se-8(1)(b)(ii) kanye no-(iii) ngokwebanga elihanjiwe ngempela;
  - (b) owanikwa umhlomulo otheliswa ochazwe kundima yesi-7 seSheduli Yesikhombisa eMthethweni Wentela Yemalingeniso; noma
  - (c) othole naliphi inani noma owaqongelela inani ngokwemisebenzi eyenziwe ngaphandle kweRiphabhulikhi.
- (3) Umuntu ngokwemvelo akudingeki ukuba athumele ifomu lokubuyisa imininingwane ngentela ngokwendima-2(f)(vii) uma—
- (a) lowo muntu aziswe nguKhomishana ngokumbhalela ukuthi ukhethelwe ukuhlolwa ngokuhlolwa okuzenzakalelayo; futhi
  - (b) umholo walo muntu ongacozuliwe, ukuxolelwa, ukubanjelwa kanjalo nezaphulelombuyiselo ezivela kumarekhodi kaKhomishana ziphelele futhi ziyiqiniso ngosuku lokuhlolwa kubhekwa ekucatshangelweni ukuze kwenziwe uhlolo oluzenzakalelayo.

#### 4. Izikhathi okumele abuyiswe ngazo amafomu okubuyisa imininingwane ngentela yemalingeniso

Amafomu emininingwane ngentela yemalingeniso kumele athunyelwe kulezi zikhathi ezilandelayo:

- (a) Maqondana nanoma iyiphi inkampani, inhlango esiza umphakathi egunyazwe uKhomishana ngokwesigaba sama-30(3) soMthetho Wentela Yemalingeniso, kanye neklabhu yezokungcebeleka egunyazwe uKhomishana ngokwesigaba sama-30A(2) soMthetho, ezinyangeni eziyi-12 kusukela ngosuku okuphela ngalo unyakamali; noma
- (b) Maqondana nabo bonke abanye abantu (okubandakanya abantu ngokwemvelo, amathrasti kanye nabantu ngokomthetho, abafana nezikhungo, imikhandlu nezinye izinhlaka)—
  - (i) mhla noma ngaphambi komhla zingama-23 kuMfumfu 2026;
  - (ii) mhla noma ngaphambi komhla zingama-22 kuMasingana 2027 uma ifomu lokubuyiswa kwemininingwane ngentela lingelomkhokhintela wesikhashana

- (iii) mhla noma ngaphambi komhla zingama-22 kuMasingana 2027 uma ifomu lokubuyiswa kwemininingwane ngentela lingelethrasti; noma
- (vi) lapho ama-akhawunti emukelwa nguKhomishana ngokwesigaba sama-66(13A) soMthetho Wentela Yemalingeniso maqondana nemalingeniso yokhokhintela ephelele noma ingxenye yawo, adonswa ngosuku olusemva komhla zingama-28 kuNhlolanja 2026 kodwa ngomhla noma ngaphambi komhla zingama-30 kuMandulo 2026, ezinyangeni eziyi-6 kusukela ngosuku lawa ma-akhawunti adonswa ngalo.

    - (ii) athunyelwe ngezobuchwepheshe ngokusizwa isisebenzi sakwaSARS ehhovisi lakwaSARS.
- (2) Amafomu emininingwane ngentela yesambabhizinisi kumele athunyelwe ngezobuchwepheshe ngokusizwa isisebenzi sakwaSARS ehhovisi lakwaSARS.
- (3) USARS ungavuma ukuthi umuntu, okudingeka ukuba athumele ifomumininingwane ngentela ngendlela emiswe kundinyana (1) noma (2), angalithumela lelo fomum ngenye indlela.
