EXTENSION OF DATE TO REQUEST A REDUCED OR ADDITIONAL ASSESSMENT IN TERMS OF SECTION 95(6) OF THE TAX ADMINISTRATION ACT, 2011 (ACT NO. 28 OF 2011)

In terms of section 95(6) of the Tax Administration Act, 2011, I, Ngobani Johnstone Makhubu, Commissioner for the South African Revenue Service, hereby extend the date by which a provisional taxpayer as defined in paragraph 1 of the Fourth Schedule to the Income Tax Act, 1962 (Act No. 58 of 1962), who received an automatic assessment in terms of paragraph 3(3) of Notice No. 7422, published in *Government Gazette* No. 54598 on 30 April 2026, may request a reduced or additional assessment to 22 January 2027. This extension applies only to provisional taxpayers whose automatic assessment was issued on or before 24 November 2026.

Ingevolge artikel 95(6) van die Wet op Belastingadministrasie, 2011, verleng ek, Ngobani Johnstone Makhubu, Kommissaris van die Suid-Afrikaanse Inkomstediens, hierby die datum waarteen 'n voorlopige belastingpligtige soos omskryf in paragraaf 1 van die Vierde Bylae tot die Inkomstebelastingwet, 1962, wat 'n outomatiese aanslag ontvang het kragtens paragraaf 3(3) van Kennisgewing No. 7422 gepubliseer in *Staatskoerant* No. 54598 gedateer 30 April 2026, 'n versoek om 'n verminderde of addisionele aanslag mag indien, tot 22 Januarie 2027. Hierdie verlenging is slegs van toepassing op voorlopige belastingpligtiges wat se outomatiese aanslag voor of op 24 November 2026 uitgereik is.
