Tshwane, 9 Phupu 2021 – Diakhaonto tsa selemo ka seng tsa lekgetho la khabone tsa selemo sa lekgetho sa 2020, se qadileng ka la 1 Pherekong 2020 mme sa fela ka la 31 Tshitwe 2020, jwale di lokela ho leshwa.

Dinyehelo tsa ditsebahatso tsa akhaonto ya bolaodi ba meedi (EXD 180) mmoho le dihlomathiso tsa yona mmoho le ditefo tse amehang tsa lekgetho la khabone di ka nyehelwa ka eFiling ho fihlela ka 15.00 ka la 29 Phupu.

Ho bapa le maikemisetso a rona a mawala a ho fana ka tlhakisetso le netefaelsetso ya boitlamo ba lekgetho le ho nolofaletsa bohole ho ikobela tefo ya lekgetho, re hhalosa ditlhoko tsena tse latelang:

1. Molefalekgetho ya lefang lekgetho la khabone ke motho ofe kapa ofe ya etsang ketso e lefiswang lekgetho e angwang ke lekgetho la khabone ka lebaka la ho ba le taolo ya tshebetso hodima lepatlelo le ntshang mesi moo tshebetso eo e etsahalang teng
2. Molefalekgetho e mong le e mong o tlameha ho ba le laesense e momahaneng bakeng sa mesi ka bobedi e lepatlelong la hae la tlhahiso ya polokelo ya bolaodi ba meedi ka lebaka la ho hlahiswa ha mesi ena e angwang ke lekgetho lena la khabone. Dikopo tsa laesense di tlameha ho tlatswa foromong ya DA185 le sehlomathisong sa DA185.4B2. Sena se tlameha ho nyehelwa mmoho le ditokomane tsa tshehetso ho *SARS Excise Registration and Licensing Hub* mane ofising e lekaleng la Alberton
3. Beng bohole ba dilaesense tsa polokelo ya bolaodi ba meedi tse hlahisang mesi ena e angwang ke lekgetho lena la khabone ba tlameha ho fana ka diakhaonto tsa bona tsa EXD 180, mmoho le ditefo tsa bona tsa sekoloto sa lekgetho la khabone, bakeng sa nako ya lekgetho ya 2020 kapa karolo efe kapa efe ya yona
4. Beng ba dilaesense ba tsebahatsang mesi ya bona ho latela dintlha tsa karolo ya 4(1) ya Molao wa Lekgetho la Khabone, 2019, ba lokela ho ela hloko hore dikgeo tse amehang tsa diakhaonto tsa bona tsa EXD 180 di ka nna tsa ba le lesedi le seng le kentswe le mabapi le dipalo tsa mesi e ileng ya tlalehwa tla se bitswang *National Greenhouse Gas Emission Reporting Regulations* tsa Lefapha la Tikoloho, Meru le Botshwasi ba Dithlapi. Beng ba dilaesense ba hananang le dipalo tse seng di kentswe tsa mesi mme ba ikgethela ho kenya tse ding ba tla lokela hore ba fane ka mabaka e ditsebahatso tsena tse ding tsa mesi

5. Beng ba dilaesense ba indasteri ya petroliamo ba lokela ho hlokomela tokisobotjha e kgutlisong ya EXD 180 bakeng sa tshebetso ya palo ya dilevi tsohle tse lokelang ho leshwa mabapi le tlahiso ya petrole ke bohlahisi ba petroliamo ka nako ya lekgetho. Ho fumana dintlha tse ding, ka kopo sheba karolo e amehang ya *C.2 Calculation of Net Levy Payable in the Completion Notes to the account*. Beng ba dilaesense bohole ba jwalo ba tlameha hore selemo le selemo ba etse dikopo tsa ho ntjhafatsa dilaesense tsa bona ka la kapa pele ho la 31 Tshitwe selemo ka seng, ho tloha ka 2021, ka ho fana ka foromo e ntjhafaditsweng bakeng sa ho fumana laesense (DA185 mmoho le sehlomathiso sa yona DA185.4B2) mmoho le ditokomane tse hlokehang tsa tshehetso ho *SARS Excise Registration and Licensing Hub* mane ofising e lekaleng la Alberton.
