Ho nama, le tsepamo le phethahatso ya ka nako ya CARF e tla boela e ntlafatsa bokgoni ba rona ba ho netefatsa boikobelo ba lekgetho le ho thibela ho qoba ho lefa lekgetho, ho qetellang ho fokoditse pokello ya lekgetho ya setjhaba le ho eketsa boima ho bao ba lefang makgetho a bona.

Jwalo ka mabotowa a molao a sikereng dimmaraka tse sebetsang tsa kcripto, re ikemiseditse ho sebetsa ka potlako ho phethahatsa CARF melaong ya rona ya lehae le ho qala ka phethahatso ya ditumellano tsa phapanyetsano hore di qale ka 2027, ho itshetlehilwe hodima metjha ya molao wa na ha e amehang. Ho netefatsa tsepamo le phethahatso e thellang bakeng sa dikgwebo le mebuso ka bobedi, bao ba rona bao re leng karolo ya mabatowa a saenileng Maemo a Tshwanang a ho Tlaleha, re tla boela re phethahatsa sena ho bapa le dinako tse boletseng ka hodimo ho itshetlehilwe hodima metjha ya melao ya na ha e amehang, le ditokiso tsa maemo ana ho latela ka moo ho dumellanweng ka teng ho OECD pejana selemong sena.

Re mema mabatowa a mang a molao ho ikamahanya le rona ka sepheo sa ho ntlafatsa mokgwatshebetso wa lefatshe ka bophara wa phapanyetsano ka lesedi o sa faneng ka sebaka sa ho ipata ho ba nang le seabo ditabeng tse mabapi le ho qoba ho lefa lekgetho."
