### SARS releases trade statistics for March 2021

**Pretoria, 30 April 2021** – The South African Revenue Service (SARS) today releases trade statistics for March 2021 recording a trade balance surplus of R52.77 billion. These statistics include trade data with Botswana, Eswatini, Lesotho and Namibia (BELN). The year-to-date (01 January to 31 March 2021) trade surplus of R96.63 billion is an improvement from the R31.67 billion surplus for the comparable period in 2020. Exports increased by 45.6% year-on-year whilst imports increased by 22.7% over the same period.

# Including trade data with Botswana, Eswatini, Lesotho and Namibia (BELN)

The R52.77 billion trade surplus for March 2021 is attributable to exports of R168.29 billion and imports of R115.52 billion. Exports increased by R37.77 billion (28.9%) between February and March 2021 and imports increased by R16.23 billion (16.3%) over the same period.

Exports for the year-to-date (01 January to 31 March 2021) increased by 25.9% to R409.13 billion from R324.91 billion over the same period during 2020. Imports for the year-to-date of R312.49 billion were 6.6% more than the R293.24 billion imports recorded during the same period in 2020. The cumulative trade surplus for 2021 is R96.63 billion.

On a year-on-year basis, the R52.77 billion trade balance surplus for March 2021 was an improvement from the R21.41 billion trade balance surplus recorded in March 2020. Exports of R168.29 billion were 45.6% more than the R115.58 billion exports recorded in March 2020. Imports of R115.52 billion were 22.7% more than the R94.17 billion imports recorded in March 2020.

February 2021 trade balance surplus was revised upwards by R2.26 billion due to the ongoing Vouchers of Correction (VOC). The revision was from the preliminary surplus of R28.96 billion to the revised surplus of R31.22 billion.

# Excluding trade data with Botswana, Eswatini, Lesotho and Namibia (BELN)

The trade data excluding BELN for March 2021 recorded a trade balance surplus of R42.87 billion.

#### Summary

The R42.87 billion surplus for March 2021 was as a result of exports of R154.19 billion and imports of R111.33 billion. Exports increased by R34.99 billion (29.4%) between February and March 2021 and imports increased by R15.59 billion (16.3%) over the same period.

The cumulative trade balance surplus for 2021 was R72.45 billion compared to R9.00 billion trade balance surplus during 2020.

Trade statistics with the BELN countries for March 2021 recorded a trade balance surplus of R9.90 billion.

#### Summary

The R9.90 billion trade balance surplus for March 2021 was as a result of exports of R14.09 billion and imports of R4.19 billion. Exports increased by R2.78 billion (24.5%) between February and March 2021 and imports increased by R0.64 billion (17.9%) over the same period.

The cumulative trade balance surplus for 2021 was R24.18 billion compared to R22.67 billion in 2020.
