UMnu. Naik wathi inkampani yawukhipha ugwayi yawusa eZambia. Le mpahla ekhishwe ezweni ibe isiphenywa kwatholakala ukuthi nembala ngumbombayi wempahla ekhishwe ezweni. Lobu bugebengu benziwa ukuze kugwenywe izintelo nentela ekhokhiswa emikhiqizweni kagwayi.

Watholakala enecala emacaleni amahlanu okukhwabanisa kanye nokuphula isigaba 80 (1) soMthetho Wentela Yempahla. Ngokobufakazi obethulwe phambi kweNkantolo yesiFunda yaseJohannesburg, uSARS ukhwabaniselwe imali engu-R18-million.

UMnu. Kieswetter uncome ithimba labaphenyi kanye nokubambisana koPhiko Lokushushisa Kuzwelonke (i-NPA) ngokuthi bakwazi ukulahla ngecala futhi bagwebe.

“USARS ubesho ephindelela ukuthi isikhungo sizokwenza kube nzima futhi kumbe eqolo kubakhokhintela nabahwebi abakhetha ukuphula umthetho futhi babukele phansi uyalelo kaSARS wokuqoqa imali engenayo.

“Sizimisele ngokulekelela labo bakhokhintela nabahwebi abafuna ukuthobela ngokuzithandela izibophezelo zabo ngokomthetho. Kuleminyaka eyedlule kusungulwe izinkundla zedijithali ukwenza kube lula kulabo bakhokhintela abanjalo ukuba bathobe.

“Lokhu kulahlwa ngecala nokugwetshwa kumele kuthumele umyalezo ocacile wokuthi uSARS ngeke akubekezelele ubugebengu obufana nalobu futhi uzokwenza konke okusemandleni ukulandela lezi zigila mkhuba,” kusho uMnu. Kieswetter.
