SARS releases trade statistics for October 2019

Pretoria, 29 November 2019 – The South African Revenue Service (SARS) today releases trade statistics for October 2019 recording a trade surplus of R3.09 billion. These statistics include trade data with Botswana, Eswatini, Lesotho and Namibia (BELN). The year-to-date (01 January to 31 October 2019) trade surplus of R5.32 billion is an improvement from the R3.70 billion deficit for the comparable period in 2018. Exports increased by 2.8% year-on-year whilst imports for the same period showed a decrease of 4.3%.

Including trade data with Botswana, Eswatini, Lesotho and Namibia (BELN)

The R3.09 billion trade surplus for October 2019 is attributable to exports of R123.35 billion and imports of R120.26 billion. Exports increased from September 2019 to October 2019 by R13.09 billion (11.9%) and imports increased from September 2019 to October 2019 by R14.53 billion (13.7%).

Exports for the year-to-date (01 January to 31 October) increased by 5.1% from R1 027.47 billion in 2018 to R1 079.72 billion in 2019. Imports for the year-to-date of R1 074.40 billion are 4.2% more than the R1 031.18 billion imports recorded in January to October 2018, leaving a cumulative trade surplus of R5.32 billion.

On a year-on-year basis, the R3.09 billion trade surplus for October 2019 is an improvement from the R5.69 billion deficit recorded in October 2018. Exports of R123.35 billion are 2.8% higher than the R120.03 billion exports recorded in October 2018. Imports of R120.26 billion are 4.3% less than the R125.72 billion imports recorded in October 2018.

September 2019's trade surplus was revised downwards by R0.63 billion from the previous month's preliminary surplus of R5.16 billion to a revised surplus of R4.53 billion as a result of ongoing Vouchers of Correction (VOC's).

Trade highlights by world zone

The world zone results from September 2019 (revised) to October 2019 are given below.

Africa:

Exports: R33 100 million – this is an increase of R3 582 million from September 2019.

Imports: R14 909 million – this is an increase of R4 346 million from September 2019.

Trade surplus: R18 191 million – this is a deterioration of R764 million in comparison to the R18 955 million surplus recorded in September 2019.

America:

Exports: R10 270 million – this is an increase of R1 051 million from September 2019.

Imports: R12 515 million – this is an increase of R2 885 million from September 2019.

Trade deficit: R2 245 million – this is a deterioration of R1 834 million in comparison to the R411 million deficit recorded in September 2019.

Asia:

Exports: R37 031 million – this is an increase of R3 771 million from September 2019.
Imports: R53 393 million – this is an increase of R4 858 million from September 2019.
Trade deficit: R16 362 million – this is a deterioration of R1 087 million in comparison to the R15 275 million deficit recorded in September 2019.

Europe:

Exports: R30 757 million – this is an increase of R459 million from September 2019.
Imports: R38 038 million – this is an increase of R2 185 million from September 2019.
Trade deficit: R7 281 million – this is a deterioration of R1 726 million in comparison to the R5 555 million deficit recorded in September 2019.

Oceania:

Exports: R973 million – this is a decrease of R288 million from September 2019.
Imports: R1 214 million – this is an increase of R191 million from September 2019.
Trade deficit: R241 million – this is a deterioration of R479 million in comparison to the R238 million surplus recorded in September 2019.

Excluding trade data with Botswana, Eswatini, Lesotho and Namibia (BELN)

The trade data excluding BELN for October 2019 recorded a trade deficit of R6.45 billion.

Summary

The R6.45 billion deficit for October 2019 is as a result of exports of R109.37 billion and imports of R115.82 billion. Exports increased from September 2019 to October 2019 by R11.58 billion (11.8%) and imports increased from September 2019 to October 2019 by R14.49 billion (14.3%).

The cumulative deficit for 2019 is R76.60 billion compared to R80.88 billion deficit in 2018.

Trade statistics with the BELN for October 2019 recorded a trade surplus of R9.54 billion.

Summary

The R9.54 billion surplus for October 2019 is as a result of exports of R13.98 billion and imports of R4.44 billion.

Exports increased from September 2019 to October 2019 by R1.51 billion (12.1%) and imports increased from September 2019 to October 2019 by R0.04 billion (1.0%).

The cumulative surplus for 2019 is R81.92 billion compared to R77.18 billion in 2018.
