

Isitatimende somphakathi: Izinsolo zokushiwo nguMnu L Montana MP njengoba kubikiwe kumaPhephandaba Azimele mhla ziye-7 kuMfumfu 2025

Tshwane, 7 kuMfumfu 2025 - UPhiko Lwemalingeniso Ezoqwayo LwaseNingizimu Afrika (uSARS) uyiqaphele imibiko yabezindaba ebikwe amaPhephandaba Azimele namuhla lapho kunezinsolo zokuthi uMnu Lucky Montana MP "umangalele" "wabeka amacala obugebengu" uSARS ngakubiza "ngesinqumo senkantolo somgunyathi njengezaba zesikweletu sentela esiphezulu". UMnu Montana uphinde wathi wamangalela uSARS esidlangalaleni ngezinsolo "zokuphatha budedengu, ukusetshenziswa kabi kwamandla kanye nokuzingelwa kwabathile okuhlobene nepolitiki".

Ngokuvamile, uSARS akakhulumi esidlangalaleni nabakhokhintela abahileleke ezinqubweni zokungaboni ngaso linye, izicelo ezingamanga kufanele zibhekwe ngokushesha. Kulokhu, kubaluleke kakhulu ukunikeza umsuka walolu daba.

Inqubo yokuqoqwa kwesikweletu ngokujwayelekile:

UMthetho Wokuphathwa Kwentela ubeka kuSARS umyalelo ngokomthetho wokuqinisekisa ukuthi intela iqoqwa ngempumelelo nangendlela esebenzayo. Le nqubo ingase ibandakanye ukufakwa kwesitatimende esiqinisekiwe nguSARS, esisoveza intela ekhokhwa kunobhala wenkantolo efanele, lapho kusebenza khona ezimweni ezithile. Esimeni esinjalo, kube sekukhishwa isinqumo sokwenza i-warrant of execution - izokwenziwa ngesikhathi esijwayelekile sokuqoqwa kwezikweletu. Lesi sitatimende esiqinisekisiwe, esinikezwe ngokusemthethweni sivuna uSARS, sibe sesisetshenziselwa ukuthola isikweletu sentela somkhokhintela. Kungumthetho onqunyiwe ukuthi isitatimende esiqinisekisiwe esitholwe nguSARS enkantolo enamandla okulawula umkhokhintela sithathwe njengesinqumo senkantolo ngenhloso yokuthola isikweletu sentela. uSARS uyakuphika ukuthi usebenzisa "izinqumo zenkantolo ezinomgunyathi njengezaba zezikweletu ezinkulu zentela".

Ukuqokwa kodaba ngokwejwayelekile:

USARS uyisikhungo sikahulumeni ngokoMthethosisekelo noMthethosivivinywa Wamalungelo Abantu. USARS uhlose ukusebenzisa imithetho yentela kanye nemithetho yokulawulwa kwempahla emngceleni abayilawulayo ngokungenzeleli, ngendlela esobala nenesandla esilinganayo ngaphandle komthelela wangaphandle. Akekho noyedwa kwaSARS onganquma ukuthi kumele kuphenywe bani, kwenziwe ucwaningomabhuku kubani, ubani ozokhokhela izikweletu zentela nokuthi ubani angamkhokhisi. USARS uthembele kuzinhlobonhlobo zezindlela zokukhetha amacala ezizenzekelayo, Ubuhlakani mbumbulu (i-AI), ezisekelwe ekubhekeni ingcuphe, ezisekelwe kumininingo kanye nezisetshenziswa zocwaningo. Ukukhethwa kwecala ukuze kuphenywe noma kucwaningwe kuncike ekwengameleni kwezindlela ezahlukahlukeni - amakomiti anemithetho yokubusa akhona ukuze acubungule futhi enze imisebenzi ethile. Wonke lawa makomiti akhona ngokomthetho, ngenqubomgomo

noma ngendlela yokuphatha futhi anemithetho ecacile. Ahlanganisa abantu abanolwazi nolwazi oludingekayo futhi bona ngokwabo balawulwa yizindlela zokwengamela. USARS iyisikhungo sikahulumeni esizimele ngokungaphelele esinezibopho ezithile zomthetho. USARS ubelokhu ewenza umsebenzi wawo ngokuzimela nangendlela engachemi futhi engakuvumeli ukugxambukela kwangaphandle. USARS uyakuphika "ukuzingelwa kwabathile okuhlobene nepolitiki".

Indlela yokusebenza yezimangalo ezingamanga zokufiphaza, ukubambezela, ukuphazamisa, ukuphikisa, nokudala umsindo ongafuneki:

Sekuyinsakavukela umchilo wesidwaba kwabanye okumele babhekane nemiphumela yezenzo zabo, ukuzama ukufiphaza, ukuphazamisa, ukuhlasela nokusebenzisa amaqhinga okulibazisa ngokusebenzisa kabi izikhalo ezisemthethweni, ukwengamela kanye nezinqubo nezindlela zophenyo, nangokufaka izinsolo ezingamanga kanye "nezikhalazo" ezingamanga nezingenabufakazi. Umlando wethu wakamuva ugcwele izibonelo zendlela abantu abaye bazama ngayo ukungena nokukhohlisa abezindaba nezinye izinkundla zomphakathi ukuze baqhubekisele phambili izimangalo nezindaba ezingamanga ukuze bathole zonke izinhlobo zemiphumela engabazekayo. Okufanayo nangokuhlukumeza nokuchitha izinsiza ze-ejensi yokuphoqeelwa komthetho ukuze kuzuzwe izihloko zezindaba ezivusa intshisekelo. Mayelana nalokhu, uSARS ubelokhu futhi usazoqhubeka nokuxoxisana nezinhloko ezehlukene zoHlelo Lwezobulungiswa Bobugebengu ngenhloso yokuhlola ukuthi lo mkhuba unganqandwa kanjani, njengoba umosha isikhathi nezinsiza ezibalulekile zezikhulu zomthetho.

USARS unxusa abezindaba ukuthi bahlale amaqiniso futhi baqinisekise ukuthi bayazazi izinqubo nezinqubo zokuphatha ezisemthethweni nezijwayelekile ngaphambi kokubika ngezimangalo nje. USARS, nabezindaba kanye nazo zonke izakhamizi zalali zwe kufanele kube yibo bonke abasebenzi bakahulumeni abathembekile, abakhuthele, nabasebenza ngokuzikhandla ukuthi baqale banqume isisusa sesimangalo, bagxeke izimangalo ezingenangqondo futhi okungenani bathole amaqiniso, ngaphambi kokuba baqhubekisele phambili izicelo zohlangothi olulodwa. Lokhu akuvimbeli noma ngubani ukuthi afune noma yiliphi ikhambi elivunyelwe emthethweni ezikhungweni zomthetho, uma kukhona icala okufanele libe khona. Kulokhu, akukho.

“Ukumangalelwa” “nokubekwa amacala”:

Uphiko Lokushushisa Lukazwelonke (i-NPA) lusungulwe ngokweSigaba 179 soMthethosisekelo futhi yisona sodwa isikhungo esinikezwe amandla okunquma ukumangalela noma yimuphi umuntu, isikhungo, noma uhlaka olusemthethweni ngobugebengu kanye nokunquma ukuthi lawo macala angaba yimaphi. Akekho omunye ngaphandle kwe-NPA ongabeka uSARS icala noma izisebenzi zawo.

USARS uvunyelwe ukudalula imininingwane yabakhokhintela esidlangalaleni ukuze uphikise izinsolo ezingamanga:

Ngokubuka okushiwo uMnu Montana, uSARS uzosebenzisa iSigaba 67(5) soMthetho Wokuphathwa Kwentela, ovumela uSARS ukuthi adalule ulwazi lomkhokhintela obeluzothathwa njengoluyimfihlo, ukuze kuziphikiswe izinsolo ezingamanga ezibekwe uSARS kanye nezinqubo zawo.

USARS ngeke wenze okunye ukuphawula emphakathini mayelana nalokhu okwamanje, kuze kube uMnu Montana wazisiwe ngokwesigaba 67 (5) soMthetho Wokuphathwa Kwentela ukuthi ahoxise esidlangalaleni lezi zicelo ezingamanga, eziyihlazo nezihlukumezanayo phakathi nesikhathi esidingekayo esingamahora angama-24. Ukwehluleka ukwenza okuthile, uSARS uzophoqeleka ukuthi adalule imininingwane eyimfihlo yomkhokhintela ukuze alungise umbono ongelona iqiniso.

USARS uphinde ukhuthaze abakhokhintela abaphikisana noSARS ukuthi basebenzise izinkundla eziqhubekayo nezikhona zokuphikisana ukuzwakalisa noma yiziphi izikhalo okungenzeka banazo.
