

SARS e ntlafatso Tshebedisano ya Matjhaba ho tsa Lekgetho Afrika le pakeng tsa dinaha tsa BRICS

Tshwane, 4 Pudungwana 2022 - Ditshebelelso tsa Lekgetho tsa Afrika Borwa (SARS) di bile le seabo dikopanong tse ngata bekeng ena ho tiisa maqhama a matjhaba a tshebedisano Afrika le pakeng tsa dinaha tsa BRICS (Brazil, Russia, India, China le South Africa).

Ho bapa le Maikemisetso a rona a Mawala a rona a 8 - a ho sebetsa mmoho le bakgathatema mmoho le Maikemisetso a rona a Mawala a rona a 9 - a ho tlisa tshepo setjhabeng, SARS e ntse e tswela pele ho aha botjha bolekane ba matjhaba le bakgathatema ba bohlokwa ba kang *OECD, Global Forum on Tax Transparency, ATAF, WCO, SADC, SACU, United Nations le IMF* mmoho le ditumellano tsa mahlakore a mabedi le ditheo tse ding tsa Lekgetho le Bolaodi ba Meedi. SARS e ikakgetse ka setotswana mme e na le seabo se ahang diforamong tsena jwalokaha ho etsahetse bekeng ena e fetileng.

Kopano ya pele e bile ya ho ba teng ka tshebediso ya khompyutha kapa ka seqo e leng Kopano ya Bosupa ya Foramo ya Taolo ya Lekgetho Afrika (ATAF) mane Lagos, Nigeria, ho tloha ka la 31 Mphalane ho fihlela ka la 3 Pudungwana 2022. Yona e ile ya latelwa ke dikopano ka tshebediso ya khompyutha tsa BRICS, tse ileng tsa tshwarwa ke Bolaodi ba Lekgetho ba Mmuso (STA) ba China jwalo ka modulasetulo wa jwale wa BRICS. Kopano ena e ne e akga ka hare Ditsebi tsa Lekgetho tsa BRICS le Dihlooho tsa Bolaodi ba Lekgetho ka la 2 le la 3 Pudungwana 2022.

ATAF

Sebokeng sa Kakaretso sa Bosupa sa ATAF se etsahalang ka mora dilemo tse ding le tse ding tse pedi, Togo le Afrika Borwa di ile tsa kgethwa hape ho ba Modulasetulo le Motlatsamodulasetulo ba ATAF, ka ho fapano. Ditho tsa Lekgotla tse kgethetsweng nako ya dilemo tse pedi ke Nigeria, Rwanda, Botswana, Burundi, Uganda, Zambia, The Gambia le Morocco. Lekgotla le fana ka tataiso e mawala le boetapele mosebetsing o etswang ke Bongodi ba ATAF. ATAF le yona e ne e keteka ho amohelwa ha South Sudan, ho ba setho sa mashome a mane a motso o le mong.

Mokotaba wa Seboka sa Kakaretso sa Bosupa, e ne e le *Rethinking Revenue Strategies: The Human Face of Taxation* mme kpano ena e bile le bakgathatema ba fetang 500 ba emetseng ditheo tse 33 tsa lekgetho mmoho le mekgatlo ya balekane e 15. Kopano e ile ya buisana ka ditaba tse fapaneng tsa lekgetho, ho akareditswe le bohlokwa ba Tshebediso ya Mehlodi ya Lehae ho ntshetsa pele tshehetso ka ditjhelete, theknoloji le mehlodi ya batho, se bitswang *Two-Pillar Solution* seo sepheo ka sona e leng ho shevana le diphephetso tse tl Lang ka lebaka la ikonomi e dijithale, diphetoho tse ntlafatso mehlodi ya tsa ditjhelete, tshebediso e phethahetseng ya mehlodi ya tlhaho mmoho le ho kgina ha diphallo tse sa dumellwang tsa ditjhelete.

Ntlhakgolo e nngwe ya kopano ena e bile ho kgakolwa ha bukana e bitswang *Handbook on the Future of Resources Taxation*. Bukaneng ena ho na le mehopolo e mabapi le ka moo mokgwatshebetso wa jwale wa lekgetho o ka ntlaufatwang kateng le hore dinaha tse ruileng ka mehlodi di ka etsa eng ho ntlaufatsa borui bona ba tsona ba dimenerale.

Khomishenara Edward Kieswetter o ile a hlekela sebaya ka puo ya hae e neng e le mabapi le *Tax and Technology – Human Centered Socially Responsible Automation*. Puong ya hae Khomishenara o tobokeditse tswelopele e seng e entswe ho ahweng ha SARS ya sejwalejwale le e sebetsang ka tsela e bohlale.

Tsena di akga ka hare tse ntle tse entsweng ke tse ding tsa ditho tsa BRICS Mananeong a Boikobelo a Tshebedisano a CONFIA, Mawala a Matjha a Botsamaisi ba Sekoloto sa Lekgetho, Tshebediso e Phethahetseng ya *Data* ya AEOI — tse latelang tse bitswang *CRS Tool, Faceless Tax Administration, AIS and Updating of Returns, Smart Individual Income Tax (IIT) Reconciliation, Tax Awareness Month, Coordination of Tax and Customs Pricing for Imported Goods* mmoho le se bitswang *Taxpayer Compliance Evaluation and Monitoring*.

Afrika Borwa e tla nka Bodulasetulo ba BRICS maqalong a 2023 mme ka mora moo e amohele baeti dikopanong tsa Lekgetho tsa BRICS ka 2023.

"Tshebedisano ya matjhaba e bohlokwa ho thusa SARS ho phethahata thomo ya yona. Ho sebetsa mmoho le bakgathatema le ka bona ho ntlaufatsa mokgwatshebetso wa lekgetho ho tsamaisana le tsela ya rona e mawala. Re tsitlallela ho ba le bolekane bo sebetsang ka ho phethahala le bo molemo le bakgathatema kaofela, lapeng mona

le matjhabeng, tikolohong ya lekgetho e tlang ka melemo e meholo bakeng sa balefalekgetho. mmuso le setjhaba. Re tshehetsa matla a e mong le e mong wa rona ho rarolla diphephetso tsa taolo ya lekgetho le ho ntlaufatsa boikobelo ba tefo ya lekgetho ka boithaopi”, ho rialo Khomishenara Kieswetter.
