**Tshwane, 18 kuMfumfu 2024** - UKhomishana woPhiko Lwemalingeniso Eeqoqwayo LwaseNingizimu Afrika (u-SARS) uMnu. Edward Kieswetter usamukele isinqumo seNkantolo Ephakeme i-Gauteng North High Court Division ethole uMnu. Ngwane Roux Shabangu enesibophokubika ngokuhluleka kwakhe ukukhokhela u-SARS izintela ezisilele azikweletwa nguye nezikhungo ezixhumene naye. UMnu. Shabangu unamabhizinisi amanangi anentshisekelo kuwo embonini yokwakha nezindlu.

Emva kwemizamo emide nethathe isikhathi eside u-SARS ugqogqa isikweletu sentela ebisisilele kusukela kowe-2019 kanye nokuzama ukugwema ukuguga kwempahla obekuzoqhubeka kwenze kube nzima ukuqoqa inani eliphelele lentela okumele ikhokhwe, u-SARS wafaka isicelo soMyalo wokuMisa owenziwa ku-*Majestic Silver 275 (Pty) Ltd*, okuyinkampani okuyiyo elawulayo ebiisetshenziswa uMnu. Shabangu kanjalo noMnu. Shabangu yena uqobo kanye namalungu omndeni wakhe ngokwezikhundla zaho zokuba ngamalungu e-The Roux Shabangu Family Trust.

Kulokhu okwabonakala njengesu eliwumzamo wokubambezela ukuvimbela ukukhishwa koMyalo wokuMisa wokugcina, i-*Majestic Silver 275 (Pty) Ltd* yafaka isicelo sokuba kuhlangulwe ibhizinisi lokhu okwakuzokwenza ukuba kubekwe umyalelo wokumisa i-*moratorium* kuzo zonke izinqubo zomthetho ezaziqhube ka egameni lenkampani ukusukela ekuqaleni kwezinqubo zokuhlangula ibhizinisi.

U-SARS waphikisana nalomzamo wokuhlengwa kwebhizinisi kwathi kuNhlanja kowezi-2023, wathola uMyalo wokuMisa wesikhashana owasusa umyalo wokumisa i-*moratorium* ohlinzekelwa ngokwesigaba 133 seMithetho yeziNkampani 71 wezi-2008 owawukhipha phambili u-SARS nowaqoka i-Curator Bonis ukuba kube yiyo ebheka izindaba ze-*Majestic Silver 275 (Pty) Ltd*, uMnu. Shabangu kanye namalungu omndeni wakhe njengabaPhatheli be-Roux Shabangu Family Trust.

KuMbasu kowezi-2024 u-SARS wathola umyalo wokuMisa wokugcina ku-*Majestic Silver 275 (Pty) Ltd* kanye nabanye Abaphendulayo. Izinqubo zokuhlangulwa kwebhizinisi i-*Majestic Silver 275 (Pty) Ltd* zabekwa eceleni futhi zamiswa.

Kwabuye kwathathwa isinqumo sokuqala ukufaka isicelo sokucwila kwenkampani egameni lezinkampani zikaMnu. Shabangu kanye nokuqalisa isicelo sokudliwa kwempahla egameni likaMnu. Shabangu kanye ne-The Roux Shabangu Family Trust lapho anguMphatheli wayo, ngokweSigaba 177 soMthetho wokuPhathwa kweNtela, uMthetho nombolo 28 wezi-2011.

KuMandulo kowezi-2024, izicelo zokucwila nokudliwa kwempahla zaxoxwa e-Gauteng North High Court. INKantolo, emva kwezingxoxo, yavuma ukuba inkampani eyodwa ibalwe njengecwile ezikweletini kanye nemiyalo emithathu yesikhashana egameni lenkampani, uMnu. UKhomishana wakwa-SARS uMnu. *ubaluleke kakhulu ngoba ugqamisa imizamo ka-SARS eqhubekayo yokuphoqeleta ukuthotshelwa kwentela kuma Thrasti okuzikhethela avamise ukusetshenziswa njengezindlela zokubalekela izintela. U-SARS angeke uguqe endleleni yawo yokulandela bonke abantu ngaphandle kokwesaba, ukwenzelela noma ukulimaza. Ngethemba ukuthi lesi sicelo sizobathuntubeka bonke labo abahlose ukulandela lo mgudu”.*
