

Ukubuyekezwa koHlu Iwabaphila nokuKhubazeka

Tshwane, 1 kuNhlanguana 2021 – UPhiko IweziMali eziNgenayo eNingizimu Afrika (SARS) lukuqaphele ukuphawula komphakathi emva kokushicilewa kohlu oluhlongozwayo lohu lokukhubazeka okufanelekayo i-“List of Qualifying Physical Impairment or Disability Expenditure” (uHla Iwabaphila nokuKhubazeka) ukuze umphakathi uphawule ngalo.

Ukuphawula okuningi kubukeka kuncike ekungaqondisisini kahle inhloso yokuchitshiyelwa kwaloluhla, okwabangelwa izethulo ezathunyelwa ababambiqhaza befisa ukuthi kubhekwe izinkinga ezikhona kuloluhla olukhona Iwabaphila nokuKhubazeka.

Ukuze sibe nesikhathi esanele sokuxoxisana nababambiqhaza, sichaze inhloso yalezi zinguquko nokuthi baconde ukukhathazeka okuvelele, sinqume ukuba siluhoxise uhla oluhlongozwayo Iwabaphila nokuKhubazeka. Olunye uhla Iwabaphila nokuKhubazeka lungase lushicilewe uma sekuphothulwe le nqubo.

Okubhalelw abahleli:

Uhla Iwabaphila nokuKhubazeka lwethulwa ngonyaka wezi-2009 ngokuchitshiyelwa komthetho woMthetho weNtelangeniso, 1962, owawudinga ukuba uKhomishana abeke uhla lokukhubazeka okufanelekayo noma incitho yabaphila nokukhubazeka. Ukuchitshiyelwa kwensiwa ngoba kuzanywa ukucacisa nokunika isiqinisekiso kwabakwaSARS nakubakhokhintela mayelana nezindleko zokukhubazeka ezifanelekayo ezizovunyelwa ngokwentela.

Uhla lokuqala Iwabaphila nokuKhubazeka lwaqala ukusebenza ngonyaka wentela wezi-2010 kuya phambili futhi lwaluncike ezidingweni zomthetho ochitshiyelwe othi incitho kumele “kube ukuthi yensiwe futhi ikhokhwe umuntu ngenxa yanoma ikuphi ukuphazamiseka noma ukukhubazeka”. Ngenkathi kuhlongozwu loluhla, uSARS uxhumane nezinhlangoano eziningi ezimele abantu abaphila nokukhubazeka kanye nezinhlangoano zongoti kulokhu, okwalandelwa isikhathi sokuthi umphakathi uphawule ngalokhu.

Uhla Iwabaphila nokuKhubazeka lwalungiswa ngonyaka wentela wezi-2013 kuya phambili, emva kwalokho kwaba ngonyaka wentela wezi-2021 kuya phambili, kulandelwa inqubo efanayo yokuxhumana.

Umgomo landelwa abakwaSARS bekulokhu kungukuhlonza lezo zindleko eziba ngaphezulu ezithwalwa abantu abaphila nokukhubazeka, okungaba ukuthi

ngaphandle kokungena kulezo zindleko lowo muntu angeke akwazi ukwenza imisebenzi ejwayelekile empilweni yakhe usuku nosuku.

Mayelana nezimali zesikole, izindleko ezifanelekayo izonu eziwumehluko phakathi kwezimali ezikhokhwa esikoleni esizimele salabo abanezidingo ezikhethekile kanye nalezo zikole ezizimele ezikhokhayo, noma umehluko phakathi kwezimali ezikhokhwa ezikoleni zikahulumeni zalabo abanezidingo ezikhethekile nalezo ezingaphansi kukahulumeni ezikhokhayo.
