Tshwane, 27 kuNhlabha 2022 - USARS uthanda ukweluleka abakhokhintela abangabameleli bamathrasti ngomsebenzi wabo wokubhalisela amathrasti intela yemalingeniso.

Amathrasti afakiwe kuncazelo yegama “umuntu” ngokoMthetho Wentela Yemalingeniso, 1962 (i-ITA), ngalokho-ke, abaphathi bamathrasti kanye nababakhokhintela abangabameleli banomthwalo wokubhalisela wonke amathrasti intela yemalingeniso. Amathrasti kudingeka ukuthi abhaliswe kubandakanya nawo wonke amathrasti akuleli, amathrasti angawona awezakhamizi apathwa kuRiphabhulikhi yaseNingizimu Afrika nakumathrasti enza imalingeniso ngomthombo waseNingizimu Afrika (ngokuqondiswa okwengeziwe bheka Imibuzomvama kusizindalwazi sakwaSARS <https://www.sars.gov.za/businesses-and-employers/trusts/>).

Abakhokhintela abangabameleli bamathrasti bangabaphathi bamathrasti, kodwa umthwalo wokuthumela amafomu emininigwane yentela ungabekwa kumphathi othile wethrasti noma ungoti wezentela. USARS ufisa ukukhumbuza abaphatheli bamathrasti ukuthi kudingeka ukuthi baqinisekise ukuthi amafomu emininigwane yentela amathrasti ayathunyelwa. Okwamanje, amathrasti noma ngabe ayasebenza noma aqubile, kumele athumele amafomu entela yemalingeniso minyaka yonke ngokuhambisana nezidingo ezikhishwa minyaka yonke uKhomishana (njengokwesidingo sesigaba 66 se-ITA). Kunyaka wezi-2021 wokuhlola, isikhathi sokubuyisa amafomu emininigwane yentela samathrasti sivule mhla lu-1 kuNtulikazi 2021.
