#### South African Trade Statistics for March 2010

Pretoria, 30 April 2010 -- The South African Revenue Service (SARS) today releases trade statistics for March 2010 that record a trade surplus of R0.46 billion.

## Summary

The R0.46 billion surplus for March 2010 was due to an increase in imports of 11.16% and an increase in exports of 27.50%.

Exports for March 2010 of R51.53 billion and imports of R51.08billion resulted in a surplus of R0.46 billion.

Imports increased by R5.13 billion (11.16%) to R51.08 billion and exports increased by R11.11 billion (27.50%) to R51.53 billion.

The trade surplus for March 2010 is R0.46 billion (Deficit of R0.57 billion in March 2009) compared to a deficit of R5.5 billion in February 2010, a month-on-month improvement of R6 billion.

The cumulative deficit for the year to date is R8.56 billion compared to R19.01 billion in 2009, an improvement of R10.45 billion or 55%.

### Trade Highlights by Category

- The February to March change (up by 11.16%) in imports of goods reflected increases mainly in:
  - Machinery and electrical appliances [up by R2.8 billion (28%)];
  - o Products of the chemical or allied industry [up by R0.7 billion (15%)];
  - O Base metals and articles thereof [up by R0.6 billion (29%)] and
  - O Plastics and rubber and articles thereof [up by R0.5 billion (33%)].
- The February to March change (up by 27.50%) in exports of goods reflected increases mainly in:
  - Mineral products [up by R3.2 billion (42%)];
  - o Precious and semi-precious stones and metals [up by R2.4 billion (24%)];
  - O Vehicles, aircraft and vessels [up by R2.0 billion (68%)] and
  - O Base metals and articles thereof [up by R1.6 billion (22%)].

# • Trade Highlights by World Zone:

The world zone results for March 2010 as given below are unaudited, and those for February 2010 are audited.

- O Asia: The deficit decreased from R5.8bn in February 2010 to R4.3bn in March 2010. Exports increased by R4.4bn to R17.4bn and imports increased by R2.9bn to R21.7bn.
- Europe: The deficit decreased from R4.5bn in February 2010 to R4.4bn in March 2010. Exports increased by R2.5bn to R13.9bn and imports increased by R2.4bn to R18.3bn.
- America: The deficit of R0.9bn in February 2010 changed to a surplus of R0.4bn in March 2010. Exports increased by R2.5bn to R6.2bn and imports increased by R1.2bn to R5.8bn.
- O Africa: The surplus increased from R1.8bn in February 2010 to R3.5bn in March 2010. Exports increased by R0.6bn to R7.6bn and imports decreased by R1.2bn to R4.1bn.
