- h) Section 4 must only be completed by an applicant who wishes to register as a Special Economic Zone (SEZ) Operator.
- i) Section 5 must only be completed by an applicant who wishes to register or license as a Customs Control Area (CCA) Enterprise.
- j) Section 6 must be completed by Customs and Excise clients who is registered or licensed.
