# INKHOMBANDLELA LEMCOKA YENTSELA YEMABHIZINISI LAMANCANE

Lenkhombandlela iniketa lwatiso lolumcoka Kumabhizinisi Lamancane, Lasafufusa Nalasemkhatsini (SMMEs) kanye netibopho tawo tentsela letimayelana nekubhalisela intsela, kufayela, nekukhokhela Temisebenti Yentsela TaseNingizimu Afrika (i-SARS). Iphindze ifake lwatiso lolumayelana naletinhlobo tentsela lokungahle kudzingeke utikhokhe kuye ngebukhulu nangenhlobo yelibhizinisi lakho.

Ngena yebunyenti betibopho temtsetfo wetentsela letimayelana netinhlobo letehlukene temabhzinisi, ngembi kwekucala libhizinisi lakho, cala ngekutsatsa sincumo ngenhlobo yelibhizinisi lofuna kulicala.

## Umsebenti wemnikati welibhizinisi

## Kukhokha intselo



Kukhokha intselo kungentiwa ngekusebentisa i-eFiling noma ngekusebentisa indlela yekundulisa imali yelibhange. Kukhokha intselo kufuneke kwenteke ngesikhatsi lesibekiwe kute uvimbele kukhokha intalo nekujeziswa. I-SARS angeke isaphindza ivume kwamukela emasheke emva kwaDisemba 2020.



## Kugcina emarekhodi

Kugcina kahle emarekhodi kukusita kutsi ukhone kuchaza loko lokubikako uma ubuyisa intselo yemalingena yakho uma kungenteka kutsi i-SARS ibe nemibuto mayelana nelwatiso lolubikako uma ubuyisa intselo yakho yemalingena. Kugcina kahle emadokumenti lafana netiliphu tekutsenga, ema-inivoyisi, emarisithi, tiliphi tekufaka imali ebhange kanye nalamanyemadokumenti kutakusita kulawula kancono tindzaba takho tentsela nasekucinisekiseni kutsi uhlala uhambisana nemtsetfo wentsela.

## Uyibhalisela nini intsela?



Uma sewuyibhalisile inkapani yakho kuKhomishane Yenkapani Neyemphahla Yekuticambela (CIPC) lebeyatiwa ngekutsi yi-CIPRO ku- [www.cipc.org.za](http://www.cipc.org.za) . Kutantakalela kutsi i-SARS ikhipe inombolo leyireferensi yakho yeNtsela Yemalingena Yenkapani (CIT). Lomelele inkapani emva kwaloku kutawufuneka abhalise ku-eFiling ye-SARS abuvekete lwatiso, bese wenta lakwentako ngendlela le-elektronikh naalemalula ne-SARS.

Umuntfu lotisebentako/Lomhwebi loyedvwa noma bantfu Labanebulingani kufuneka babhalisele Intselo Yemalingena Yabo (PIT) ngco ku-SARS ngekusebentisa i-eFiling.

### Sibopho sakho sentsela

Noma ngabe ungumuntfu lotisebentako noma lonelibhizini, kufuneka ubhalise libhizini lakho ku-SARS, ufayelele Imbuyiselo Yentsela yakho bese ukhokha intselo ledzingekako kusanesikhati.

### Tindlela letimalula tekutsintsana ne-SARS

Kutsintsana kwakho lokunyenti ne-SARS kutawenteka nge-inthanethi ngekusebentisa i-eFiling ye-SARS. Uma uhweba ungumuntfuloyedvwa futsi ungenayo inombolo leyireferensi yemalingena yentsela yakho, kufuneka ucale ngekubhalisela kuba mkhokhuntsela ku-eFiling kute wakhe ipprofayili yakho, inombolo leyireferensi yentsela yakho itawentiwa.

### Kubhalisela i-eFiling:

- » Uma ungumhwebi losebenta yedvwa noma Unebalingani – Dawuniloda i-MobiApp ye-SARS ku-Google Play Store (kuma-Android) noma i-App Store (kutinsita te-Apple) bese uchafata 'REGISTER'.

Uma lonkhe lwatiso lwakho selubeyeketiwe, kakhulukati imininingwane yakho yasebhange, imininingwane yekuchumana kanye nemleli wenkapani ungabhalisela letinye tinhlobo tentsela letifana ne-VAT, PAYE, njll. ku-eFiling, ngaphandle kwekuya kuligatja le-SARS.

## Tintsela letikhetskile letisebenta kumabhizinisi lamancane

Kunetikhutsati letinengi letikhona temabhizinisi lamancane letifana neNtsela Yemali Lesetjentiwe (TOT), Intsela Yetinhlangano Temabhizinisi Lamancane (SBC) kanye Nentsela Yesikhutsati Sekucasha (ETI).

### 1. Intsela Yemali Lesetjentiwe (TOT)

Intsela Yemali Lesetjentiwe ihlose kunciphisa nekwenta kukhokha intselo kube malula futsi nekucedza umtfwalo wekulawula kumabhizinisi lamancane lenta Inzudo yemnyaka le-R1 million noma ngaphasi kwaloko.

Loluhlelo Lwentsela Yemali Lesetjentiwe luluhlelo lolulodvwa lwentsela futsi lume esikhundleni Sentsela Yemalingena, se-VAT, Sentsela Yesikhashana, Sentsela Yemali Lenkhulu Nesentsela Yetabiwo. Emabhizinisi lafanelekile atawubika bese akhokha yinye (1) intselo (ngaphandle uma akhona kukhetsa i-VAT noma i-PAYE) bese acala kukhokha intselo uma inzudo layentako ngemnyaka ingetulu kwe-R335 000.

### 2. Inhlangano Yemabhizinisi Lamancane (SBC)

Emabhizinisi lamancane lenenzozo yemnyaka lefika ku-R20 million angafaneleka kukhokha Intsela Yemalingena ngelizinga lelincishiwe lensesela. Uma uveta kutsi libhizinisi lakho lincane kuMbuyiselo Yakho Yentsela Yemalingena (ITR14), futsi lihambisana nesidzingo lesibekiwe, lamazinga lancishiwiwe atawuvele asebente. Akunasidzingo sekufaka sicelo sekunciphisa emazinga ngoba simo sakho sebu-SBC sitawubukwa ngekulandzela Iwatiso loluku-ITR14.

## Intsela Lengetiwe (VAT)

Emabhizinisi lanesilinganiso noma tinzudo tangempela letingetulu kwe-R1 million kudzingeka abhalise futsi abite 15% i-VAT kuleto tintfo netinsita letikhokhelwa intselo.

## Tigaba Tekubhalisela i-VAT:

Sidzingo sitsi lokutsengisive kufuneka kube sevele kwendlule umkhawulo we-R50 000, noma kungahle kwendlule R50 000 ngesikhatsi lesitinyanga leti-12. Kubhalisela i-VAT usebentisa i-eFiling ye-SARS kuyasheshisa futsi kumalula.

## Pay-As-You-Earn (PAYE)

Umcashi lobhalisile noma lekufuneka abhalise ne-SARS abhalisele i-PAYE naye kutawudzingeka kutsi abhalise futsi akhokhe Intsela Yekutfukisa Emakhono (SDL) futsi akhokhe nemnikelo Wesikhwama Semshwalensi Walabangasebenti (UIF) ku-SARS.

Cinisekisa kutsi uyabhalisa ku-SARS kungakendluli tinsuku tekusebenta leti-21 emva kwekuba ngumcashi, dvonsa imali ye-PAYE neye-UIF kumiholo yetisebenti bese uyikhokha ku-SARS njalo ngenyanga. Lemali lena kufuneka ikhokhwe kungakendluli tinsuku letisikhombisa (7) emva kwekuphela kwenyanga. Lapho khona imiholo yetisebenti ingaphansi kwemkhawulo lobekiwe.

## Intsela Yesikhashana

Kuyatentakalela kutsi tonkhe tinkapani tibhaliselwe Intsela Yesikhashana ngesikhatsi tibhalisela Intsela Yemalingena Yetinkapani. Bantfu labanelibhizinisi lelincane futsi batfola imali kulelibhizinisi, ngaphandle kwemholo, kufuneka babhalisele Intsela Yesikhashana. Kufuneka ugcwalise bese utfumela Imbuyiselo Yekukhokha Intsela Yesikhashana (IRP6) kabilo ngemnyaka bese ukhokha silinganiso semalingena yakho.

Lembuyiselo ingafayelwa ngekusebentisa i-eFiling ye-SARS. Kodvwa uma ubhaliselwe Intsela Yemali Lesetjentiwe, akunasidzingo sekutfumela i-IRP6.

## Intsela Yemalingena Yetinkapani (CIT)

Tinkapani kufuneka tibike imalingena yato njalo ngemnyaka ngekufumela Imbuyiselo Yentsela Yemalingena Yetinkapani (ITR14) uma kubhaliswa kwato sekupheleliwi. Lokubika kufuneka kunembe, kuchaze yonkhe imalingena netindleko kute kugwenyewe kwenta iuhlolo lolusetulu noma loluphasi. Umnyaka weluhlolo lophela mhlaka, nobe emuva kwamhlaka 31 iNdlovulenkhulu, silinganiso somtselo wemalingena yemabhizinizi singu 27% (ngaphambili sasingu 28%).
