Khuyini okufuze uyiveze?

Nanyana ngubani ongena namkha ophuma eRephabhliki yeSewula Afrika kufuze ahlathulule ngokutjhaphulukileko izinto ezilandelako:

- Yoke ipahla (kuhlanganise nepahlala yomunye umuntu) esemntwini loyo namkha ayiphetheko ethengiweko namkha efunyenwe ngaphetjheya namkha elethwe ngomkhumbi, ngekoloji namkha evela esitolo esithengisa ipahla kodwana akhenge kubhadelwe umthelo; ipahla eyenziwe kabutjha, namkha elungisiweko, nakafikako.
- Ipahla ekhandelweko namkha ebekelwe umkhawulo ngaphasi komthetho othileko
- Ipahla ebekufuze iveauze ngaphambi kobabana iphume eRephabhliki.

Ngaphambi kobana iphume, yoke ipahla ephethwe mkhambi afuna ukuphuma nayo eRephabhliki ehlanganisa ipahla le:

- Ayiphathele omunye umuntu
- Eyenziwe kabutjha, namkha elungisiweko
- Ekhandelweko, ebekwelwe umkhawulo namkha elawulwako ngaphasi komthetho othileko
- Ipahla angena nayo okwesikhathjana eRephabhliki, ebekufuze ayiveze nakangenako eRephabhliki.

Abakhambi kufuze nabakhonjelwa Mphathi wezeMithelo, bamnikele amaphepha apheleleko wepahla njengama-invoyisi, amaphepha wesithuthi, ubufakazi bokuthi ipahla ithengiwe, incwadi egunyazako namaphemithi athileko wepahla leyo. Ukungezelela kilokho, abakhambi ngokuzeleko kufuze baphendule imibizo ebuzwa mphathi loyo, kufuze bayiveze begodu bayivule bona ihollwae njengombama balayelwa mphathi begodu kufuze babbadele imali nomthelo ofunekako nangabe lokho kungokomthetho.

Ngisiphi isibonelelo semithelo okungatlhogeki usibhadelele?

Isibonelelo sephala yomuntu mathupha namkha yezinto ezizokulahlwa ebeziphethe isipho njengombana ifakwe emthwaleni womkhambi iyavezwa sisakhamuzi senarheni nemntwini ongasisisisakhamuzi seRephabhliki.

Ipahla nanzi ezingeniswako zivezwa bakhambi emithwalenabo bangatjhatjhululwa ekubhadeleni umthelo ofunekako nomThelo Ongezelwelko i-Value-Added Tax (VAT):

- Ipahla etja namkha esebenzileko yenani elingadluli iR5 000 emntwini ngamunye
- Iwayini elingadluli amalitha ama-2 emntwini ngamunye
- iinselo zempiriti nomunye umhlobo wotjwala, yenani elingadluli ilitha e-1 emntwini ngamunye
- Namagwayi ayi-20 / amagwayi ayi-200 womuntu ngamunye
- Amagwayi amagremu ayi-250 namkha ipeypu yogwayi yomuntu ngamunye
- Amakha angadluli amamililitha ayi-50 nomhlobo wamakha abizwa ngokuthi yi-eau de toilette ongadluli amamililitha ayi-250 emntwini ngamunye.

Iwayini, iinselo zempiriti nomunye umhlobo wotjwala, iinthako zogwayi namakha ezingeniswa ngobudisi esikhulume ngabo neghla kufuze zibhadelwe ngokwefuneko eHlelweni Nombolo1 ("umThelo") ku-Customs and Excise Act No.91 ka-1964. Ipahla ekukhulunye ngayo le kanengi ibizwa ngokuthi esetjenzisako namkha ipahla yezinga eliphezulu begodu inani lomthelayo lingabaphezulu nangabe isilinganiso esiphethwe bakhambi singehla kwalesi ekukhulunye ngaso, nakunjalo kufuze abhadele inani lelo begodu abhadelela umthelo wokungenisa wenani elifunwa mthetho.

Ngitjho nanyana nayithengwakho umuntu loyo akhenge abhadelayo nakayithengako, isibonelelo sokuyitjhaphulula siyatlhogeka nawufikako.

Tjheja: Isibonelelo okungatlhogeki ubhadele umthelo kiso esisebenza epahleni etja nesebenzileko yenani eliyi-R5000 umuntu ngamunye, siyasebenza nesibonelelweni somthelo ongeziweko wesibonelelelo okungatlhogeki ubhadele umthelo epahleni ethengiswako.

Ingangani imali yokuhlola?

- Nangabe unezinto zakho ezifika ku-R5 000 yesibonelelo ekubhadeleni umthelo kodwana zingadluli imali engaba yi-20 000- mhlamunye ungakhetha ukubhadela amaphesenti ayi-20 ngaphandle kwe-VAT kunokobana utjhaphulule ipahla ngenani lomthelo otlolwe ku-Schedule No. 1 ("umthelo") yoMthetho wemithelo yepahla yeenarheni zangaphandle newepahla yangenarheni i-Customs and Excise Act Nombolo 91 we 1964



- Ipahla yenani le-R20 000 elivunyelweko lokuhlola, ukubhadela imisebenzi umthelo ongeniswako ne-VAT ngokuvumelana nehlathululo ye-Harmonised System nobujamo bapahla.

Ubujamo besibonelelo:

- Umthelo okungatlhogeki uwubhadele wephahla etja namkha esebezenzileko uvunyelwe kwaphela kanye emntwini ngamunye hlangana nesikhathi samalanga ama-30, alandelwe kungabi khona okungadluli ema-irini ayi-48 eSewula Afrika
- Imali yokuhlola ivumeleke kwaphela Phakathi namalanga ayi-30 begodu akukafuzi isebezenzileko epahleni engeniswa mumuntu obuyako ngemva kokungabi khona ngemva kwama-iri angaphasi kwayi-48
- Isibonelelo somthelo okungatlhogeki uwubhadele malungana newayini, ama-spiriti neminye imihlolo yotjwala, ugwayi namkha zivunyelwe kanye phakathi namalanga ayi-30, alandelwe kungabi khona okungadluli ema-irini ayi-48 eSewula Afrika
- Ipahla kufuze ikhambisane nemithwalo
- Isibonelelo segwayi notjwala akukafuzi sinikelwe abantu abangaphasi kweminyaka eyi-18.

Kuthiwani ngezinto ezenziwe ngezandla?

- Abakhambi bangangenisa izinto ezenziwe ngezandla zesikhumba, isigodo, iplastiki, amatje namkha irhalasi elifika kumagremu ayi-25 ezithengelwe ukwenza irhwebo ngaphandle kokubhadela isibobho namkha umthelo.

Kuthiwani ngepahla oyingenisako engekhe ihlale isikhathi eside?

Kungenzeka ubawe bona ukhiphe idiphozithi bona ubhadele umthelo namkha i-VAT epahleni edurako. Imalakho izokubuyiselwa ngemva kokuqinisekiswa ukuthi ipahla leyo uylkhophile enarheni.

Ipahla ekhandelweko nebekelwe umkhawulo

- I-SARS ijamele iminyango eminengi karhulumende, izakhiwo nemikhandlu ngokuthi ilawule izinto ezithileko ezikhanelweko nezibekelwe umkhawulo
- Okukhandelweko kutjho ukuthi ipahla leyo ayikavunyelwa bona ingene namkha iphume eSewula Afrika
- Okubekelwe umkhawulo kutjho ukuthi ipahla leyo kuvumelekile bona ingene namkha iphume eSewula Afrika ngaphasi kwemibandela ethileko ngokwesibonelo, kufuze ube nephepha elikuvumelako namkha isitifketi.

Bona ufumane irhelo "Prohibited and restricted goods SC-CC-32", vakatjhela ikhasi leMithetho Yabarhwebi ye-SARS kuzinzolwazi ye-SARS ku- www.sars.gov.za.

Tjheja: Abarhwebi nabakhambi kufuze bazi ngomThetho weZinto Zomdubulo i-Counterfeit Goods Act Nombolo 37 we 1997, ehlathulula ukuthi ipahla eyenzive yaba sezengeni eliphasi namkha ethengiswa ngaphasi kwebizo lenye ibhizinisi, elingakagunyazwa mnikazi wayo, kuphula umthetho lokho okuzokwenza bona kuthathwe amagadango nokuthi/ namkha isepulamthetho sizokuthathelwa amagadango wobulelesi.

Imikhawulo yemali

- Abakhambi bavunyelwe bona bangaphatha imali efikela ku-R25 000 / imali enganasilinganiso yangaphandle, kwaphela nabaphukako namkha nabangenako
- Umkhambili kufuze aveze amaphepha webanka, igolide, isekhurithi namkha imali yakenye inarha ayiphetheko
- Imali yeSewula Afrika ayinasilinganiso nangabe uyaphuma / uyangena enarheni ngokwesiLinganiso seMali ePheze Ifane (CMA)
- Abakhambi bakhuthazwa bona badosele iBhanka eKulu yeSewula Afrika bona bafumane imvumo ngaphambili kobana badlulisele imali ngale kwemkhawulo
- Ngitjho nanyana kunganasilinganiso esingokomthetho sokuthi kufuze uphathe imali enganganani nawukhamba ngesiphaphamtjhini, nangabe uyangaphetjhuya kufuze uveze imali engaphezu kwe-\$10,000 eforomini lakho lokubhadela, kufuze ulungele nokubuzwa imibuzo njengombana kufunwa mthetho kufuze uhlathulule bona inganganani imali leyo oyiphetheko.

I-Southern African Customs Union (SACU)

Ilinarra eziwela ngaphasi kwe-South African Customs Union (SACU) yiLesotho, yiNamibia, yiSewula Afrika, yiBotswana ne-Eswatini.

Abakhambi eenarheni ezimalunga we-SACU akukafuzi babhadele umthelo ojayelekileko begodu akukafuzi babhadele i-VAT epahleni engaba yi-R5 000.

Ngingayitolisela nini ikhowudi yebhizinisi?

- Ngaphambi kobana ipahla ingeniswe namkha iphume, i-SARS kungenzeka izokufuna umuntu namkha ibhizinisi ittoliswe ngokomthetho namkha igunyazwe ngaphambi kobana yenze nanyana ngimuphi umsebenzi onqotjhisa yi-Act.
- Umuntu, kuhlanganise nomkhambi, ongenisa namkha okhambisa ipahla inani layo elifunekako lingaphasi kwe-R150 000 hlangana nekhala yomnyaka loyo ayifakwa eemfunekweni zokutlolisa.

Umuntu ongakafakwa eemfunekweni ezingokomthetho angasebenzisa ikhowudi ethi 70707070 ebujamweni napu obulandelako:

- Mumuntu wamambala
- Ufaka ipahla ethengelwe ukusetjenziswa ngendlini, ukhambisa okwesikhatjhana namkha uyathumela
- Ibonakala esitlankaneni sokubhadela sokungenisa namkha sokukhupa:
 - Inomboro yereferensi yomthelo wokubhadelwa yeZiko leSewula Afrika lezomThebo; namkha
 - Inomboro yepasa yeSewula Afrika, malungana nesakhamuzi seSewula Afrika namkha isakhamuzi sasafuthi seRephabhliko, namkha inomboro yepaspoti malungana nomuntu ongasie ngeweSewula Afrika namkha isakhamuzi sasafuthi.

Ukubuyiswa komthelo komuntu ovakatjhileko othenge okuthileko

UmThebo Ongezelelwoko (VAT) yenani le-15% iyadoswa nawuthenga ipahla ethileko eSewula Afrika. Abantu abavakatjhileko namkha abavakatjhi abavela ngaphetjheya nabeza eSewula Afrika bangafaka isibawo sokuthi nabaphumako bafumane imbuyselo ye-VAT ebhadelweko. Ama-invoyisi womthelo/ubufakazi bokuthenga begodu ipahla leyo kufuze bayiveze naselekuhlolwa izinto ngaphambi kobana baphume.

Kuzokwenzekani nangabe ngibhalelwu kulandela umthetho eemfunekweni zebhizinisi lami?

ISARS ilwela ukufundisa nokwazisa abarhwebi ngeembopho zabo zomthelo ngendlela ezinengi, ukwenzela bona ikuze wenze izinto ngenaneko. Abarhwebi abazokufunyanwa bangalandeli umthetho bazokuqalana nemiphumela yokuphula umthetho we-Penal Provisions of the Customs and Excise Act Nombolo 91 we 1964, ehlanganisa amakonyana wesikolodo, ihlawulo, namkha ukumangalelwu ngebanga lobugebengu.
