# South African Revenue Service (SARS)

# 1. How can persons with disabilities access online training, considering that attending physical workshops may be a challenge?

You can submit your training request to <u>education@sars.gov.za</u>. Our Taxpayer and Trader Education Product Unit (TTEP) will handle the delivery.

# 2. Are business grants taxable by SARS?

No. Any government grant or government scrapping program received or accrued under a programme or scheme which has been approved under the national annual budget process and identified by the Minister in the *Government Gazette*, is exempted from normal tax.

# 3. Can SARS offer training for fewer than 20 people?

Yes, SARS can train fewer than 20 people. Send the request to <u>education@sars.gov.za</u>. The first option will be to attend the trainings in various offices across the country as outlined on this webpage: <u>https://www.sars.gov.za/individuals/who-pays-tax/how-do-i-learn-about-taxes</u>.

# 4. How can small businesses contact SARS?

# 5. If I owe SARS money and the debt is accumulating interest, must I deregister my company? I have no assets that I can sell to cover the SARS debt. The company itself is not generating income.

SARS cannot deregister a non-compliant taxpayer. You can ask SARS to suspend the company, but for deregistration to be completed, the taxpayer must be fully compliant, with no outstanding payments and all tax returns up to date.

# 6. How can I join the Authorised Economic Operator (AEO) programme?

# 8. Where can I get a Mutual Recognition Agreement (MRA)?

The MRAs are not published on the website yet.

#### 9. Is SARS's SMME Newsletter legitimate?

Yes. The SARS SMME Taxpayer and Trader Segment publishes quarterly newsletters, synchronised with the SARS compliance calendar. To receive critical updates from SARS, such as these newsletters, traders and taxpayers must keep their contact information, including email addresses, up to date. Most SMME traders receive updates through email.

# 10. Where does SARS post information about workshops that accommodate persons with disabilities?

#### 11. How long does it take to repay a loan from Sefa?

The minimum is 60 months, and the maximum is five years.

# 12. Can I apply for the Township and Rural Entrepreneurship Programme (TREP) if my business operates outside a township?

No. TREP is restricted to businesses operating in township and rural areas (villages). Businesses that are based elsewhere (e.g. towns and cities) can apply for normal Sefa funding.

#### 13. How long does it take Sefa to pay out loans?

Disbursement of funds takes four to six weeks, depending on the terms of the loan that must be met before payout.

# 16. For businesses operating across three provinces, does each region process its own applications? In which province should we submit our request for funding for our enterprise operating in the three provinces?

You must apply to Sefa in the province where your business is headquartered and registered. Use the registered business address that is registered with Companies and Intellectual Property Commission (CIPC). Our online system will assign you to the relevant Sefa regional office.

# 17. I have an audio-visual business, supplying services to the hospitality and events industry. Is my business considered a tourism business?

Yes, if the end customers (consumers) are tourists, it will be classified as a tourism business. The business participates in the tourism value chain.

#### 18. Is there a calendar for this year's DTIC international trade exhibitions?

#### 21. Does recycling qualify for funding, and under which category or classification does it fall?

Yes, recycling is eligible for funding, and the DTIC online platform will direct the application to the appropriate lending programme and sector.
