

## AUTHORISED ECONOMIC OPERATOR – COMPLIANCE

The Authorised Economic Operator Compliance programme, also known as Level 1 Accreditation, is a voluntary programme in which participating entities or traders cooperate with SARS Customs to maintain high-quality measures in terms of internal operational processes and computer systems, appropriate records of compliance, sufficient financial resources, as well as display sufficient Customs knowledge to be held responsible for Customs matters.

## AUTHORISED ECONOMIC OPERATOR – SAFETY AND SECURITY

The Authorised Economic Operator safety & security programme also known as Level 2 Accreditation is a voluntary supply chain security programme, focused on improving the security of entities' or traders' supply chain through a documented process for determining and alleviating risk throughout their international supply chain.
