Poultry meat – chickens, turkeys, ducks and muscovies (fresh or frozen) – whole carcasses and any portion for human consumption, including offal.

Does not include mechanically deboned meat.

GN R.1283/2019

Processed meat products for human consumption (excluding aquatic animals) – cured, cooked, partially cooked, reformed, coated, dried and fermented.

Examples: Cooked silverside, Country ham, Edible whole muscle offal (i.e. pickled tongue), Gammon, Pastrami, Roast beef (cured), Carpaccio, Roast beef (uncured), Roast pork, Uncured biltong, Bacon, Gammon (partial heat treated), Kasseler, Pickled tongue (partial heat treated), Cured biltong, Koppa, Pancetta, Smoked beef, Meat Loaf, Polony, Russian, Vienna, Bockwurst, Debriziners, Frankfurters, Rookwors, Smokies, Wieners, Biltong wheels or discs, Dried wors, Cabanossi, Cervelat, Metwurst, Salami, Teewurst, Blanched pork sausages, Chicken viennas (uncured), Fully cooked burgers, Polonies, Reformed nuggets, Schnitzels, Reformed hams, Reformed chicken, Turkey rolls, Reformed bacon, Reformed kasseler chops.

Dairy and imitation dairy products for human consumption

Examples: milk, flavoured milk and milkshake, cultured milk, buttermilk and cultured buttermilk, sweetened condensed milk, evaporated milk, yoghurt, strained yoghurt and drinking yoghurt/with added foodstuff and/or fruit. cream, cultured cream & acidified cream, cheese with or without added foodstuff, process cheese & cheese spread with or without added foodstuff, cream cheese with or without added foodstuff, cottage cheese with or without added foodstuff, butter and cultured butter with or without added foodstuff, modified butter and cultured modified butter with or without added foodstuff, dairy powder and dairy powder blend, milk fat products, dairy liquid blend and cultured dairy liquid blend, dairy desserts with or without added foodstuff and/or fruit, imitation dairy products.
