Boemo jwa Go Ikobela Melao ya Lekgetho (Tax Compliance Status [TCS]) bo ne jwa emisetsa tsamaiso ya Setifikeiti sa gore Ga o Kolote Lekgetho se se kileng sa bo se dirisiwa ke SARS

Tsamaiso e ntsha ya TCS e go letla go amogela **TCS PIN** ka nako e o batlang ka yone, mo boemong jwa go newa Setifikeiti sa Lekgetho ka bosone.

Fa e le gore ga o ise o nne modirisi wa eFiling, ikwadise mo www.sarsfiling.co.za. O tshwanetse go bo o ikwadiseditse eFiling mme o na le mofuta o le mongwe wa lekgetho o o o duelang mo porofaeleng ya gago ya eFiling, gore o simolodise tirelo ya TCS.

2 Simolodisa tirelo ya gago ya Boemo jwa Go Ikobela Melao ya Lekgetho

O tshwanetse go simolodisa Boemo jwa gago jwa Go Ikobela Melao ya Lekgetho gangwe fela, mme bo tla tswelela bo sa fetoge. Fa o sena go simolodisa tirelo eno, o tla bona "My Compliance Profile" mo sekerining.



Fa o ikwadiseditse mofuta o le mongwe wa lekgetho mme o ise o kopanye mafuta ya lekgetho mo porofaeleng e le nngwe e e kwadisitsweng, go tshitshinngwa gore o tlatse "Merge Entities" go bona porofaele ya makgetho otlhe.

3 Leba "My Compliance Profile"

Boemo jwa gago jwa go ikobela melao ya lekgetho bo tla bontshiwa le go bapsiwa le dipatlafalaloe tse di latelang tsa go ikobela melao ya lekgetho:

- Boemo jwa go ikwadisa
- Go romela diforomo tsa lekgetho
- Sekoloto
- Ditokomane tse di maleba tse di tshegetsang bosupi.

Go tla tlhaga porofaele e e nang le mmala go supa gore a o ikobela melao ya lekgetho mo patlafalang nngwe le nngwe ya go ikobela melao ya lekgetho e e mo lenaaneng le le fa godimo.

4 Kopa PIN ya eFiling

Go kopa PIN ya go tsena mo "My Compliance Profile":

- Tlhophya seitlhophelwa sa Kopo ya Boemo jwa Go Ikobela Melao ya Lekgetho
- Tlhophya mofuta wa TCS o o batlang go dira kopo ya one. O tlile go nna le ditlhopho tse di latelang:
 - » Go sa kolote
 - » Thendara
 - » Dipeeletsomadi kwa Nageng e Sele (tsa batho ka bongwe fela)
 - » Go fudugela kwa nageng e sele (ga batho ka bongwe fela)
- Tlatsa Kopo ya Boemo Jwa Go Ikobela Melao ya Lekgetho mme o e romele kwa SARS.

O tla newa PIN kwantle ga go senya nako ka SMS kgotsa ka imeile fa merero ya gago ya lekgetho e le mo maemong a a siameng.

Tlhopho 1:

Baya motsu wa gago mo godimo ga "Non-compliant" mo eFiling go bona dintlha go ya pele tsa gore o ka baakanya jang boemo jwa gago jwa go ikobela melao ya lekgetho le go tsaya kgato e e tshwanetseng.

Tlhopho 2:

Fa o sa dumelaned, e bile o batla go ntsha ngongorego ka boemo jwa go ikobela melao ya lekgetho, tlhophya seitlhophelwa sa "Challenge Status" kwa tlase mo sekerininbg sa "My Compliance Profile"



Ke mang yo o tla netefatsang boemo jwa gago jwa go ikobela melao ya lekgetho

Go ka nna ga nna le maemo a mo go one mongwe (motho ka bongwe kgotsa setlamo se sengwe kgotsa setheo sa puso) a tlhokang go netefatsa boemo jwa gago jwa go okobela melao ya lekgetho fa o dira kopo ya go newa thendara, gore ga o kolote - go netefatsa gore a maemo a gago a lekgetho a eme sentle kwa SARS kgotsa go amogela madi a Dipeeletsomadi tsa Naga e Sele.
