SARS releases the preliminary trade statistics for January 2023

Pretoria, 28 February 2023 – In the year 2022, South Africa recorded a fully year total trade balance surplus of R211.6bn (exports of R2.02trn and imports of R1.81trn constituting a total trade of R3.83trn).

Today, the South African Revenue Service (SARS) releases trade statistics for January 2023 recording a preliminary trade balance deficit of R23.05 billion. The R23.05 billion preliminary trade balance deficit for January 2023 is attributable to exports of R139.36 billion and imports of R162.41 billion.

These statistics include trade data with Botswana, Eswatini, Lesotho and Namibia (BELN). The year-to-date (01 January to 31 January 2023) preliminary trade balance deficit of R23.05 billion is a deterioration from the R4.64 billion trade balance surplus for the comparable period in 2022. Against January 2022, the January 2023 exports increased by 6.1% (from R131.39bn to R139.36bn) whilst imports increased by 28.1% (from R126.76bn to R162.41 billion).


On a month-to-month basis, exports decreased by R23.48 billion from R162.83 billion to R139.36 billion (-14.4%) between December 2022 and January 2023 and imports increased by R4.56 billion from R157.85 billion to R162.41 (2.9%) over the same period.

December 2022 preliminary trade balance surplus was revised downwards by R0.45 billion due to the ongoing Vouchers of Correction (VOC). The revision was from the preliminary trade balance surplus of R5.43 billion to the revised trade balance surplus of R4.98 billion.



The trade data excluding BELN for January 2023 recorded a preliminary trade balance deficit of R30.26 billion.


Summary

The R30.26 billion preliminary trade balance deficit for January 2023 was as a result of exports of R126.81 billion and imports of R157.07 billion. Exports decreased by R20.82 billion (-14.1%) between December 2022 and January 2023 and imports increased by R3.22 billion (2.1%) over the same period.


The preliminary cumulative trade balance deficit for 2023 was R30.26 billion compared to R2.63 billion trade balance deficit during 2022.

Trade statistics with the BELN countries for January 2023 recorded a preliminary trade balance surplus of R7.21 billion.


Summary

The R7.21 billion preliminary trade balance surplus for January 2023 was as a result of exports of R12.55 billion and imports of R5.34 billion. Exports decreased by R2.67 billion (-17.5%) between December 2022 and January 2023 and imports increased by R1.34 billion (33.4%) over the same period.


The preliminary cumulative trade balance surplus for 2023 was R7.21 billion compared to R7.26 billion in 2022.
