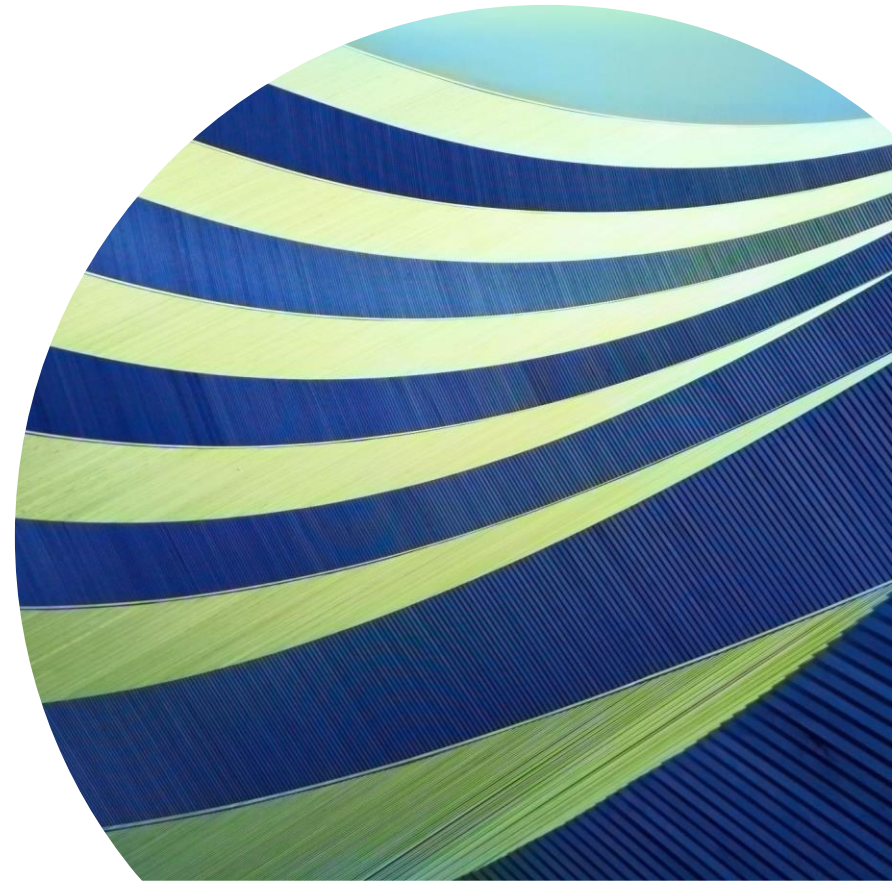

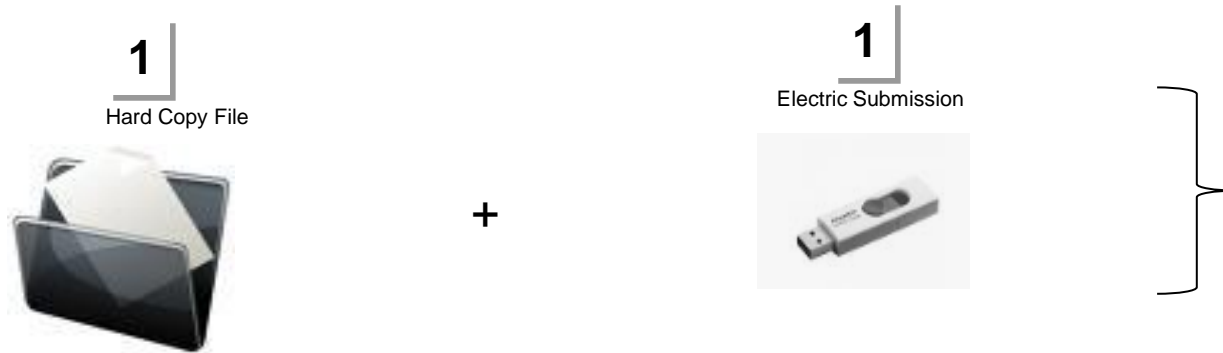
5. SERVICES LEVEL AGREEMENTS (SLA)
