

**NOTES REGARDING AMENDMENTS TO THE SCHEDULES
TO THE CUSTOMS AND EXCISE ACT, 1964**

20 FEBRUARY 2004

These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.

<i>Provision</i>	<i>Note</i>
5701.10 5701.90 and 5702.10	The rates of duty on carpets and other textile floor coverings, knotted, whether or not made up and on "Kelem", "Schumacks", "Karamanie" and similar hand-woven rugs are reduced from 30% (General) and 24% (EU) respectively to 5%.
7605.21.70 7605.21.80 7605.29.05 7605.29.80	The effect of this amendment is that the rate of duty on wire of aluminium alloys is reduced from 5% to free and the eight digit subheadings are deleted.
8482.10	The effect of this amendment is that duty on radial deep groove ball bearings are reduced from 20% to free and the structure of the subheading is amended.
210.02/4802.5/02.05 210.02/4802.5/04.05 210.02/4802.5/05.05 210.02/4802.5/06.05	The provisions for an anti-dumping duty on uncoated paper and paperboard, white, not containing fibres obtained by a mechanical process, of a mass of 40 g/m ² or more but not more than 150 g/m ² , of a kind used for writing, printing or other graphic purposes, and punch card stock and punch tape paper, in rolls or sheets (excluding paper of heading 48.01 or 48.03 and monoglazed poster paper and paperboard, in rolls of a mass of 40g/m ² or more but not exceeding 120 g/m ²) imported from or originating in Brazil and Poland, are withdrawn.

303.01/1511.90/02.06	Provision is made for a rebate of the full duty on palm stearien, not chemically modified, for dehydrating and blending with paraffin wax, of which the palm stearin content exceeds 20 per cent or more by mass.
