

**NOTES REGARDING AMENDMENTS TO THE SCHEDULES
TO THE CUSTOMS AND EXCISE ACT, 1964**

23 JUNE 2004

These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.

	A provisional payment in relation to anti-dumping duty is imposed on:
5515.21,	(a) woven fabrics of synthetic staple fibres, containing 85 per cent or more by mass of acrylic fibres;
5512.29,	(b) woven fabrics of synthetic staple fibres, containing 85 per cent or more by mass of acrylic fibres;
5515.29,	(c) woven fabrics of synthetic staple fibres, containing acrylic fibres;
5515.91,	(d) woven fabrics of synthetic staple fibres, containing acrylic fibres;
5801.34,	(e) woven warp pile fabrics, épingle (uncut) containing acrylic fibres;
5801.35,	(f) other woven warp pile fabrics, cut (excluding fabrics of headings 58.02 or 58.06) containing acrylic fibres;
6001.10,	(g) "long pile" fabrics, knitted or crocheted, containing acrylic fibres;
6001.22 and	(h) looped pile fabrics, knitted or crocheted containing acrylic fibres (excluding fabrics of a mass not exceeding 250 g/m ²); and
6001.92	(i) other pile fabrics and terry fabrics, knitted or crocheted containing acrylic fibres, originating in or imported from Turkey.

**CUSTOMS AND EXCISE ACT, 1964.
IMPOSITION OF PROVISIONAL PAYMENT (P/P/120)**

Under section 57A of the Customs and Excise Act, 1964, the provisional payment imposed up to and including 13 August 2004, in terms of Government Notice No R. 173 of 13 February 2004 published in Government Gazette No. 26005 is hereby substituted by a provisional payment in relation to anti-dumping duty up to and including **13 August 2004**, to the extent and on the goods set out in the Schedule hereto.
