

**NOTES REGARDING AMENDMENTS TO THE SCHEDULES
TO THE CUSTOMS AND EXCISE ACT, 1964**

13 APRIL 2007

These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.

206.02/2922.41/03.06	The provision for an anti-dumping duty on lysine originating in or imported from Indonesia, is withdrawn, with retrospective effect to 25 January 2007.
207.01/3920.20/01.06	An anti-dumping duty is imposed on plates, sheets, film, foil and strip of biaxially oriented polymers of propylene, non-cellular and not reinforced, laminated, supported or similarly combined with other materials of a thickness exceeding 0,012 mm but not exceeding 0,06 mm not heat shrinkable exported by Empresa Brasileira de film flexiveis Ltda (EBFF).
207.01/3920.20/02.06	An anti-dumping duty is imposed on plates, sheets, film, foil and strip of biaxially oriented polymers of propylene, non-cellular and not reinforced, laminated, supported or similarly combined with other materials of a thickness exceeding 0,012 mm but not exceeding 0,06 mm not heat shrinkable exported by Polo Industria E Comercio Ltda.
207.01/3920.20/03.06	An anti-dumping duty is imposed on plates, sheets, film, foil and strip of biaxially oriented polymers of propylene, non-cellular and not reinforced, laminated, supported or similarly combined with other materials of a thickness exceeding 0,012 mm but not exceeding 0,06 mm not heat shrinkable exported by Vitopel do Brasil Ltda.
207.01/3920.20/04.06	An anti-dumping duty is imposed on plates, sheets, film, foil and strip of biaxially oriented polymers of propylene, non-cellular and not reinforced, laminated, supported or similarly combined with other materials of a thickness exceeding 0,012 mm but not exceeding 0,06 mm not heat shrinkable (excluding those exported by Empresa Brasileira de film flexiveis Ltda (EBFF), Polo Industria E Comercio Ltda and Vitopel do Brasil Ltda) originating in or imported from Brazil.
