

**NOTES REGARDING AMENDMENTS TO THE SCHEDULES
TO THE CUSTOMS AND EXCISE ACT, 1964**

27 FEBRUARY 2009

These notes are issued merely as a guide and both the old and new provisions should be studied in order to determine what the amendment actually entails. These notes have no legal status.

<i>Provision</i>	<i>Note</i>
3917.32.15	The effect of this amendment is that provision is made for a new subheading for lay-flat, seamless tubing made from polymers of ethylene with a thickness of 200 microns or more but not exceeding 300 microns, printed, having a burst pressure of less than 0,5 Mpa and an inside cross-section of 200 cm or more but not exceeding 500 cm, at a free rate of duty.
3917.32.20	The effect of this amendment is that subheading 3917.32.20 is amended to exclude lay-flat, seamless tubing made from polymers of ethylene with a thickness of 200 microns or more but not exceeding 300 microns, printed, having a burst pressure of less than 0,5 Mpa and an inside cross-section of 200 cm or more but not exceeding 500 cm from the payment of duty.
3922.90	The effect of this amendment is that the tariff structure has changed.
3922.90.10	The effect of this amendment is that a new subheading is inserted to make provision for portable toilets of plastics, with a mass not exceeding 5 kg and with a removable waste tank with a capacity not exceeding 20 litres, at a free rate of duty.
3922.90.90	The effect of this amendment is that subheading 3922.90.90 is amended to exclude portable toilets of plastics, with a mass not exceeding 5 kg and with a removable waste tank with a capacity not exceeding 20 litres from the payment of duty.
