7.	Please confirm the following:	For quantitative phase a sample of 3000 is required for each year a survey is conducted,
	- For the quantitative phase, is the sample of 3000 interviews currently conducted on an annual basis, or is it spread over the 36 month period specified in the RFP?	e.g. Year 1 = 3000; Year 2 = 3000 and Year 3 = 3000.
	- Are the interviews currently being spread over the year, or are they done in one specified period of time? If they are done in one specified period of time, can you tell us when this is? This will be important when designing the study, from a tracking point of view.	The survey is not necessarily done during a specific period, however it should be within each year.
	- Under Scope of Work on page 7 of the RFP, one of the requirements will be to review and enhance existing survey instruments. Can you advise when we would be provided with copies of these documents, as well as how the sample is currently designed?	Bidders will not be provided with the survey instrument or sample framework. Only a successful bidder with have access to the survey instrument.
