Another company's documents (e.g. its BEE certificate) cannot be used/evaluated in respect of your company and would lead to your bid proposal being disqualified.

The bidder(s) must create awareness of and promote wellness services by providing employees with the relevant soft copy wellness information material such as desk drop, teasers and newsletters.
10	Please confirm if Wellness Calendar Day Campaigns are to be provided in 1 region per month and if providers will be required to be present at every office within that region.	Each campaign will be held in one region as determined by SARS (other regions will receive soft copy and other relevant material related to the campaign as may be required). The campaign will be held in one office in a selected region as determined by SARS.
11	Is the Behaviour Risk Management Survey be conducted online for the entire employee population?	Bidder is required to conduct client satisfaction surveys through a telephone or web-based system to each user of the services.
12	Please advise if any printed marketing materials will be required at time of the launch of the programme.	The printed material will only be required at a site where the campaign is held. Other offices will receive soft copies.
13	Please confirm what is expected from emails sent to the GBV email account for EWP e.g. would the provider be required to refer to safe houses, call police etc	This is for people to either report and where necessary, based on risk assessment, victim can be directed to resources such as safe houses, call police if necessary. The utilisation of that platform can be captured in the report.
