

**FIXING OF A DATE ON WHICH SECTIONS 12(1) AND 33(1) OF THE REVENUE LAWS SECOND AMENDMENT ACT, 2006 (ACT NO. 21 OF 2006), AND SECTION 11(1) OF THE TAXATION LAWS SECOND AMENDMENT ACT, 2007 (ACT NO. 9 OF 2007), SHALL COME INTO OPERATION**

In terms of sections 12(2) and 33(2) of the Revenue Laws Second Amendment Act, 2006 (Act No. 21 of 2006), and section 11(2) of the Taxation Laws Second Amendment Act, 2007 (Act No. 9 of 2007), I hereby fix **1 October 2008** as the date on which section 12(1) and section 33(1) of the Revenue Laws Second Amendment Act, 2006, and section 11(1) of the Taxation Laws Second Amendment Act, 2007, shall come into operation.






